

ORDINANCE NO. 14

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF ADDISON, DALLAS COUNTY, TEXAS; AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS AND OWNERS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition requesting that the hereinafter described territory be annexed to the City of Addison, Texas, has been signed by the majority of the inhabitants of such described territory who are qualified to vote for members of the State Legislature; and

WHEREAS, said land is adjoining the City of Addison and said petition was presented to the Mayor and City Council of the City of Addison requesting the annexation of said territory to said City; and

WHEREAS, the members of the City Council of the City of Addison have approved the petition requesting the annexation of said territory; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1: That the following described property, to-wit:

All that certain tract, lot or parcel of land situated in the County of Dallas, State of Texas, being adjacent to the present City Limits of the City of Addison, Texas, and being more particularly described as follows:

BEGINNING at a point in the present City Limits of the City of Addison at its intersection with the west right of way line of Addison Road, said point being at the intersection of the west right of way line of Addison Road and the north right of way line of Keller Springs Road (as relocated by Ordinance dated January 8, 1957);

THENCE North along the west right of way line of Addison Road a distance of ~~2366~~ feet to a point for corner;

THENCE West at right angles to Addison Road and parallel to Keller Springs Road (as relocated) and ~~2366~~ feet therefrom to the east right of way line of Dooley Road;

THENCE South along the east right of way line of Dooley Road a distance of ~~2846~~ feet to the north right of way line of Keller Springs Road (as relocated);

THENCE East along the north right of way line of Keller Springs Road, being the northern boundary line of the City of Addison, to the place of beginning.

be, and the same is hereby annexed to the City of Addison, Dallas County, Texas, and that the boundary limits of the City of Addison be and the same are hereby extended to include the above described territory within the city limits of the City of Addison, and the same shall hereinafter be included within the territorial limits of said City and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Addison, and they shall be bound by the acts, ordinances, resolutions and regulations of said City.

SECTION 2: That this ordinance shall take effect from and after its passage as the law in such cases provides.
