AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF ADDISON, TEXAS; EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS AND GRANTING TO ALL THE INHABITANTS AND OWNERS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition requesting that the hereinafter described territory be annexed to the City of Addison, Texas has been signed by all of the owners of such described territory; and

WHEREAS, the said land is adjoining the City of Addison, Texas and said petition was presented to the Mayor and the City Council of the City of Addison requesting the annexation of said territory to said City; and

WHEREAS, the members of the City Council of the City of Addison have approved the petition requesting the annexation of said territory; and

WHEREAS, the City Council of the City of Addison on the 11th day of October, 1960, passed an ordinance annexing the hereinafter described territory; and

WHEREAS, the City Council of the City of Addison desires to pass a corrective ordinance correcting an error in the description of said territory: NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS: SECTION 1. That the following described property, to-wit:

> BEING all of that certain lot, tract or parcel of land situated in Dallas County, Texas, and being out of the W. H. Witt Survey, Abstract No. 1609, in Dallas County, Texas, and being described by metes and bounds as follows:

BEGINNING at a point in the East line of Dooley Road, a 40-foot road, 1983.73 feet South from its intersection with the South line of Keller Springs Road as said roads are now located on the ground;

THENCE North 89⁰ 54' 25" West a distance of 520.5 feet to a point for corner;

THENCE South and parallel with Dooley Road a distance of 452.22 feet to a point for corner in an old established fence line;

THENCE South 89° 38' 50" East along said old fence line a distance of 520.5 feet to a point in the East line of Dooley Road, an old iron pipe found for corner;

THENCE North with and along the east line of Dooley Road a distance of 454.4 feet to the PLACE OF BEGINNING, and containing 5.00 acres of land, more or less,

be and the same is hereby annexed to the City of Addison, Dallas County, Texas, and that the boundary lines of the City of Addison be and the same are hereby extended so as to include the above described territory within the City Limits of the City of Addison, and the same shall be hereinafter included within the territorial limits of the said City and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Addison, and they shall be bound by all of the acts, ordinances, resolutions and regulations of said City.

SECTION 2. That this ordinance shall constitute a correction of the description contained in an ordinance passed by the City Council of the City of Addison on October 11, 1960.

SECTION 3. That this ordinance shall take effect from and after its passage, as the law in such cases provides.
