AN ORDINANCE OF THE CITY OF ADDISON, TEXAS, APPROVING AND ADOPTING A BUDGET FOR THE CITY FOR THE FISCAL YEAR OCTOBER 1, 1970 THROUGH SEPTEMBER 30, 1971; PROVIDING THAT EXPENDITURES FOR SAID FISCAL YEAR SHALL BE MADE IN ACCORDANCE WITH SAID BUDGET AND DECLARING AN EMERGENCY.
