WHEREAS, the City of Dallas and the City of Addison have had for many years a fine relationship in resolving mutual problems of both cities, and it is the desire of the City Council of the City of Dallas to disannex the hereinafter described property in order that it may be annexed by the City of Addison, and in so doing the City of Dallas by the enactment of this ordinance disannexes the hereinafter described property and waives its extraterritorial jurisdiction in order that said area may be annexed by the City of Addison; Now, Therefore, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DALLAS:

SECTION 1. That the following described tract of land be, and the same is hereby disannexed and discontinued as part of the City of Dallas in order to accomplish the purpose set forth above, so that the same will no longer be a part of the City of Dallas for any purpose whatsoever, said tract of land being more particularly described by metes and bounds as follows:

BEING a tract of land situated in the Wm. Lomax Survey, Abstract No. 792, and the Eli Shepherd Survey Abstract No. 1361 in Dallas County, Texas, said tract also includes all or part of City of Dallas Block Nos. 8228, 8229, 8230, A/8230, 8231, 8232, 8233, 8234, 8235, 8236 and being more particularly described as follows:

BEGINNING at a point in the city limit line of the City of Dallas, said point being the intersection of the east line of Addison Road and the Dallas/Collin County line;

THENCE East, along said county line 350.21 feet;

THENCE S 01° 58' 00" W. along the west line of Dallas Parkway, 2082.94 feet;

THENCE in a southerly direction continuing along said west line with a curve to the left, said curve having a central angle of 28° 44' 24" and a radius of 1600.00 feet, a distance of 1396.73 feet;

THENCE S 47° 59' 26" E continuing along said west line; 1540.78 feet to the beginning of a curve to the right, having a central angle of 30° 43' 39" and a radius of 1400.00 feet;

THENCE along said curve and said west line of Dallas Parkway, 750.81 feet;

THENCE leaving the said west line of Dallas Parkway, S 89° 44' 31" W, 1251.22 feet to a point for corner;

THENCE S 0° 18' 01" E, 817.48 feet to a point for corner;

THENCE S 88° 34' 50" E, 150.01 feet to a point for corner;

THENCE S 0° 26' 40" E, 676.06 feet to a point for corner;

THENCE S 89° 21' E, 205.5 feet to a point in the west line of Hanger Road, a 40 foot road;

THENCE South along the west line of Hanger Road, 123.0 feet to its intersection with the city limit line of the City of Dallas, said city limit line being the south line of Keller Springs Road, a 50 foot road;

THENCE in a westerly and northerly direction following the City Limit Line of the City of Dallas to the place of beginning and containing 151.989 acres of

SECTION 2. That pursuant to the agreement between the Cities of Addison, Texas and Dallas, the City of Dallas hereby relinquishes any and all extraterritorial jurisdiction which it has or may have under the provisions of the Municipal Annexation Act (being Article 970a, Vernon's Revised Civil Statutes of the State of Texas), and upon the passage of this ordinance the said City of Dallas shall no longer have or exercise any right, jurisdiction or control over the above described tract of land.

SECTION 3. That upon final passage of this ordinance, the City Secretary shall certify one copy hereof and transmit same to the City of Addison.

SECTION 4. The fact that the best interest and welfare of the general public will be served by the City of Dallas disannexing the above described tract of land so that same may be annexed by the City of Addison, so that the common corporate limit line of said cities may be adjusted, required that this ordinance shall take effect immediately from and after its passage and it is accordingly so ordained.
