ORDINANCE NO. 321

AN ORDINANCE OF THE CITY OF ADDISON, TEXAS AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF ADDISON, AS HERETOFORE AMENDED, SO AS TO GRANT A SPECIAL USE PERMIT FOR THE SALE OF ALCOHOLIC BEVERAGES FOR ON-PREMISES CON-SUMPTION, UNDER SPECIAL CONDITIONS, TO CASE #283, HUSH PUPPIES, INCORPORATED; AND BEING MORE PARTICULARLY DES-

CRIBED AS FOLLOWS:

Being a tract or a parcel of land situated in the City of Addison, Dallas County, Texas; and being part of the Elisha Fike Survey, Abstract 478, and also being a part of a 26.1091 acre tract of land conveyed to Robert W. Collins, Trustee, by deed dated June 21, 1973, and recorded in Volume 73122, Page 0836, of the Deed Records of Dallas County, Texas, and being more particularly described as follows:

BEGINNING at a point for corner in the south line of Belt Line Road (100 foot wide) said point being the northwest corner of a 1.153 acre tract conveyed to the City of Addison by deed recorded in Volume 71193, Page 1455, of the Deed Records of Dallas County, Texas;

THENCE South 0 degrees 03' East along the west line of said 1.153 acre tract conveyed to the City of Addison, passing at 368.22 feet the southwest corner of said 1.153 acre tract a total distance of 489.51 feet to a point for corner;

THENCE West a distance of 200.60 feet to a point for corner;

THENCE North 0 degrees 03' West a distance of 507.62 feet to a point for corner in the south line of Belt Line Road (100 feet wide);

THENCE South 84 degrees 48' 45" East along the south line of Belt Line Road (100 feet wide) a distance of 176.12 feet to the beginning of a curve to the left;

THENCE in an easterly direction along the south line of Belt Line Road and along said curve to the left having a central angle of 0 degrees 29' 51", a radius of 2914.93 feet, and an arc length of 25.31 feet to the POINT OF BEGINNING and containing 100,000 square feet, more or less, or 2.2957 acres.

PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE: PROVIDING FOR NO SEVERABILITY: AND PROVIDING FOR THE EFFECTIVE DATE: WHEREAS, the City Planning Commission of the City of Addison and the Governing Body of the City of Addison, in compliance with the laws of the State of Texas and the ordinance of the-City of Addison, have given requisite notices by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property owners generally, and to all persons interested and situated in the affected area and in the vicinity thereof, and in the exercise of its legislative discretion, have concluded that the Comprehensive Zoning Ordinance should be amended; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1. That the Comprehensive Zoning Ordinance of the City of Addison, Texaş, as heretofore amended, be, and the same is hereby amended by amending the Zoning Map of the City of Addison, so as to grant a Special Use Permit for the sale of alcoholic beverages, as follows:

"Sale of alcoholic beverages for on-premises consumption" Said Special Use Permit shall be granted, subject to special conditions, on the following described property, to-wit:

Being a tract or a parcel of land situated in the City of Addison, Dallas County, Texas; and being part of the Elisha Fike Survey, Abstract 478, and also being a part of a 26.1091 acre tract of land conveyed to Robert W. Collins, Trustee, by deed dated June 21, 1973, and recorded in Volume 73122, Page 0836, of the Deed Records of Dallas County, Texas, and being more particularly described as follows:

BEGINNING at a point for corner in the south line of Belt Line Road (100 foot wide) said point being the northwest corner of a 1.153 acre tract conveyed to the City of Addison by deed recorded in Volume 71193, Page 1455, of the Deed Records of Dallas County, Texas;

THENCE South 0 degrees 03' East along the west line of said 1.153 acre tract conveyer to the City of Addison, passing at 368.22 feet the southwest corner of said 1.153 acre tract a total distance of 489.51 feet to a point for corner;

THENCE West a distance of 200.60 feet to a point for corner;

THENCE North 0 degrees 03' West a distance of 507.62 feet to a point for corner in the south line of Belt Line Road (100 feet wide);

WENCE South 84 degrees 48' 45" fast along the south line of Belt Line Boad (100 and wide) a distance of 176.12 feet to the beginning of a curve to the left;

THENCE in an easterly direction along the south line of Belt Line Road and along said curve to the left having a central angle of 0 degrees 29' 51", a radius of 2914.93 feet, and an arc length of 25.31 feet to the POINT OF BEGINNING and containi 100,000 square feet, more or less, or 2.2957 acres.

SECTION 2. That the above Special Use Permit is granted subject to the following conditions, to-wit:

1. That prior to the issuance of a Certificate of Occupancy, said property shall be improved in accordance with the site plan, landscape plan, and the elevation drawings showing four (4) exterior walls which are attached hereto and made a part hereof for all purposes;

2. That the Specific Use Permit granted herein shall be limited to:

Sale of alcoholic beverages for on-premises consumption only and to that particular area designated on the site plan attached hereto as being outlined in red and encompassing 9782 square feet.

- 3. No signs advertising sale of alcoholic beverages shall be permitted under other than those authorized under the Liquor Control Act of the State of Texas, and any sign ordinance of the City of Addison, as well as the approved elevations of the building.
- 4. That the sale of alcoholic beverages under this specific use permit shall be permitted in restaurant only. Restaurant is hereby defined as an establishment which receives at least sixty percent (60% of its gross revenue from the sale of food, except that wine sales shall not be included in the calculation of gross revenues.
- 5. Said establishment shall make available to the city or its agents, during reasonable hours its bookkeeping records for inspection, if required by the city to insure that the conditions of Section 4 are being met.
- 6. Dancing and the use of gaming devices, such as billiards (pool) tables, pinball machines, marble tables, and other coin operated amusement machines, other than machines for music, are hereby prohibited.
- 7. Any use of property considered as a nonconforming use under the Comprehensive Zoning Ordinance of the City of Addison shall not be permitted to receive a license or permit for the sale of alcoholic beverages.
- 8. That if the property for which the special use permit is granted herein is not used for the purposes for which said permit was granted within one (1) year after the adoption of this ordinance, the City Council may authorize hearings

9. That if a license or permit to sell alcoholic beverages on property covered by this special use permit is revoked, terminated or cancelled by proper authorities, the City Council may authorize hearings to be held for the purpose of considering a change of zoning.

SECTION: 3. That it is the intention of the City Council that this ordinance be considered in its entirety, as one ordinance, and should any portion of this ordinance be held to be void or unconstitutional, then said ordinance shall be void in its entirety, and the City Council would not have adopted said ordinance if any part or portion of said ordinance should be held to be unconstitutional or void.

SECTION 4. That any person, firm or corporation violating any of the provisions of this ordinance shall, upon commission, be deemed guilty of a misdemeanor, and shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense, and each day said violation continues shall constitute a separate offense.

SECTION 5. The fact that the sale of alcoholic beverages in the City of Addison is authorized only under special use permits as provided for in the Comprehensive Zoning Ordinance of the City of Addison, and the City Council having found that the property described herein is suitable for such use should be granted, this ordinance shall become effective from and after its adoption, and publication of the caption of said ordinance. as the law in such cases provides.
