AN ORDINANCE OF THE CITY OF ADDISON, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF ADDISON, TEXAS, AS HERETOFORE AMENDED SO AS TO CHANGE THE HEREINAFTER DESCRIBED PROPERTY, CASE #323, EDUARDO C. ESTEVE, BEING SITUATED IN DALLAS COUNTY, TEXAS AND LOCATED IN THE CARROLL ESTATES ADDITION, CONTAINING A TOTAL OF 246,740 SQUARE FEET OF LAND, FROM R-1" RESIDENTIAL DISTRICT CLASSIFICATION TO "C" COMMERICAL DISTRICT CLASSIFICATION WITH A VARIANCE FOR LIGHT ASSEMBLY; PROVIDING FOR A PENALTY NOT TO EXCEED THE SUM OF TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; PROVIDING FOR A REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

WHEREAS, the City Zoning Commission of the City of Addison,
Texas, and the Governing Body of the City of Addison in compliance with the laws of the State of Texas with reference to the
granting of zoning changes under the zoning ordinance and zoning
map, have given requisite notices by publication and otherwise,
and, after holding due hearings and affording a full and fair hearing to all property owners generally and to all persons interested
and situated in the area, the City of Addison, Texas, is of the
opinion that the said change of zoning on application of Eduardo
C. Esteve, should be granted and the Comprehensive Zoning Ordinance
should be amended in the exercise of its legislative direction:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1. That the Comprehensive Zoning Ordinance of the City of Addison, Texas, be, and the same is hereby amended by amending the Zoning Map of the City of Addison so as to give the hereinafter described property the following zoning district classification, towit: "C" Commercial District Classification with a variance for light assembly being an assembly of components which by the assembly process do not constitute a nusiance by reason of noise, noxious fumes, dust, etc. Said property being in the City of Addison, Dallas County, Texas, and being described as follows:

Being 246,740 sq. ft. in Lot 21 and the East 100' of Lot 3 in Block B of Carroll Estates Addition, an Addition to the City of Addison, Texas according to the plat thereof recorded in Volumn 10, pate 473 of the map records of Dallas County, Texas.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are, hereby repealed and all other ordinances of the city not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That the above described property shall be used only in the manner and for the purposes for in the Comprehensive Zoning Ordinance of the City as amended herein by the granting of this zoning classification.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional, and shall not affect the validity of the Comprehensive Zoning Ordinance as a whole.

SECTION 5. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of the City as heretofore amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 6. Whereas, the above described property requires that it be given the above zoning classification in order to permit its proper development and in order to protect the public interest, comfort, and general welfare of the city and creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage and publication of the caption as the law in such cases provides.
