ORDINANCE NO. 565

AN ORDINANCE OF THE CITY OF ADDISON, TEXAS, ADOPTING THE RULES AND REGULATIONS OF THE UNIFORM PLUMBING CODE, 1979 EDITION, AND SUCH OTHER REVISED EDITIONS AS ADOPTED BY THE INTERNATIONAL ASSOCIATION OF PLUMBING AND MECHANICAL OFFICIALS, TO PROVIDE MINIMUM STANDARDS TO SAFEGUARD LIFE OR LIMB, HEALTH, PROPERTY, AND PUBLIC WELFARE BY REGULATING AND CONTROLLING THE DESIGN, CONSTRUCTION, INSTALLATION, QUALITY OF MATERIALS, LOCATION, OPERATION AND MAINTENANCE OF PLUMBING APPARATUS AND FIXTURES; AMENDING SAID CODE TO PROVIDE FOR THE BOARD OF APPEALS; PERMIT FEES; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON,
TEXAS:

Plumbing Code, 1979 Edition, as adopted by the International Association of Plumbing and Mechanical Officials are hereby adopted as the rules and regulations regulating and controlling the design, construction, installation, quality of materials, location, operation, and maintenance of plumbing apparatus and fixture within the City.

The Uniform Plumbing Code, 1979 Edition, (a copy of which, authenticated by the signature of the Mayor and City Secretary, and made a public record by Ordinance, is on file in the City Secretary's office) is

hereby adopted as the Uniform Mechanical Code of the City as fully as

if copied at length in this Ordinance, but with the following changes

therein and additions thereto.

SECTION 1. That the rules and regulations of the Uniform

SECTION 2. The Uniform Plumbing Code, 1979 Edition, as adopted in Section 1 hereof is hereby modified by the following deletions, amendments and additions:

Section 20.3. Violations and Penalties. Amended to read, "Any person, firm or corporation, violating any of the provisions of this Code shall be subject to a fine, upon conviction in Municipal Court, in any sum not to exceed two hundred dollars (\$200.00) and each and every day of continuance thereof shall constitute a distinct and separate offense."

The owner or owners of any building or structure failing to comply with any provisions of this dode, and the owner or owners of any premises wherein a violation of the provisions of this code occurs, and any architect, engineer, designer, builder, contractor, agent, person, firm or corporation employed therewith and who has assisted in the commission of any such violation, shall be guilty of a separate offense.

- Section 20.4. Permit Fees. Amended to read, "No permit fee is required except for repairs, alterations and additions as per attached fee schedule, Exhibit A."
- Section 20.14. Board of Appeals. Amended to read, "In order to determine the suitability of alternate materials and type of construction and to provide for reasonable interpretations of the provisions of this Code, there shall be and is hereby created a Board of Appeals consisting of three (3) Council Members of the City. The Building Official shall be an ex officio member and shall act as Secretary of the Board. The Board shall adopt reasonable rules and regulations for conducting its investigations and shall render all decisions and findings in writing.

SECTION 3. All other Ordinances and parts of Ordinances in conflict with this Ordinance shall be, and the same are hereby repealed, but the repeal of such Ordinances or parts of Ordinances shall not affect any right, property or claim which was or is vested in the City of Addison, Texas, or any act done, or right accruing or accrued, or established, or any suit, action or proceeding had or commenced before the time when this Ordinance shall take effect; nor shall said repeals, amendments or changes affect any offense committed, or any penalty or forfeiture incurred, or any suit or prosecution pending at the time when this Ordinance shall take effect under any of the Ordinances or sections thereof so repealed.

SECTION 4. In the event that any section, paragraph, sub-division, clause, phrase, or provision of this Ordinance or the Uniform Plumbing Code, 1979 Edition, or revisions thereof, adopted herein shall be adjudged invalid or held unconstitutional, the same shall not effect the validity of this Ordinance or of the Uniform Plumbing Code, 1979 Edition, or revisions thereof as a whole or any part of provision other than the part so decided to be invalid or unconstitutional.

SECTION 5. That the City of Addison, Texas has not adopted the Uniform Plumbing Code, 1979 Edition, governing the design, construction, installation, quality of materials, location, operation, and maintenance of plumbing apparatus and fixtures within the City creates an urgency and an emergency and in the preservation of the public health, safety and welfare, requires that this Ordinance take effect immediately from and after its passage and the publication of the caption, as the law in such cases provides.
