ORDINANCE NO. <u>6/8</u>

AN ORDINANCE OF THE CITY OF ADDISON, TEXAS PROVIDING A MANDATORY MONTHLY CHARGE FOR GARBAGE COLLECTION, HAULING AND DISPOSAL FOR RESIDENTIAL PROPERTY: PROVIDING FOR PENALTY FOR LATE PAYMENT: PROVIDING A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO HUNDRED DOLLARS (\$200.00) FOR EACH OFFENSE; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES HERETOFORE ENACTED; AND PROVIDING FOR EFFECTIVE DATE OF ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1. All owners, lessee or persons in possession of residential property shall be charged a mandatory monthly fee for garbage collection, hauling and disposal from residences situated within the corporate limits of the City as follows:

Curb-side pickup for each single dwelling unit . . \$7.00

SECTION 2. That such rates or charges hereby fixed and prescribed shall be paid by the users to the Finance Department upon receipt of the monthly statement, and which shall be the date such rates or charges shall become due and payable; and in case any user or customer of such system does not pay the amount due by such user or customer of such service by the tenth day of the next month following the date same becomes due and payable, then it is hereby made the duty of the Finance Department to add a ten percent (10%) penalty to the amount past due; which amount is included with said water and sewer charges for that month and said ten percent (10%) will be added to the total of said water, sewer and garbage charges.

SECTION 3. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor upon conviction in the Municipal Court, shall be subject to a fine not to exceed the maximum sum of Two Hundred Dollars (\$200.00) for each offense and each and every day of continuance thereof shall constitute a distinct and separate offense.

SECTION 4. All ordinances, orders, or resolutions, or parts thereof, heretofore passed and adopted by the City Council in conflict herewith, shall be and the same are hereby repealed.

SECTION 5. The fact that the City of Addison, Texas does not have an adequate ordinance providing for garbage collection fee creates an urgency and emergency and in the preservation of public health, safety and welfare, requires that this ordinance shall take effect immediately from and after its passage and the publication of the caption, as the law in such cases provides.
