ORDINANCE 619

AN ORDINANCE OF THE CITY OF ADDISON, TEXAS, AMENDING
TRAFFIC ORDINANCE # 502 PASSED BY THE CITY COUNCIL ON
THE 8TH DAY OF MAY, 1979, BY AMENDING SECTION 42 TO PROVIDE ADDITIONAL LOCATIONS FOR STOP SIGNS; BY AMENDING
SECTION 43 TO PROVIDE ADDITIONAL LOCATION FOR YIELD
RIGHT-OF-WAY SIGN; PROVIDING FOR POSTING OF SIGNS;
PROVIDING FOR REMOVAL OF VEHICLES IN VIOLATION OF SAID
ORDINANCE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1. That the City of Addison's ordinance #502, passed and approved by the City Council of the City of Addison, Texas, on May 8, 1979, is hereby amended to add the following:

That Section 42 is hereby amended to provide the driver of a vehicle to stop in accordance with state law at the following added_locations:

SECTION 2. That Section 43 is hereby amended to provide the placing of yield right-of-way signs at the following locations:

SECTION 3. That the City Traffic Engineer is hereby directed and authorized to place appropriate signs at said location to be clearly visible to the public.

SECTION 4. The Chief of Police or any other officer of the Police Department of the City of Addison shall be hereby directed and authorized to order removed or remove any vehicle parking in violation of this ordinance, such violation being deemed injurious to health, safety and general welfare of the public within the City of Addison.

SECTION 5. All ordinances heretofore passed and approved by the City Council that are in conflict with this ordinance are hereby repealed except that this shall not affect the accepting, filing and prosecuting of cases for offense occurring prior to the effective date of this ordinance.

SECTION 6. It is hereby declared to be the intention of the City Council of the City of Addison that the Section, Paragraphs, Sentences, Clauses, and Phrases of this Ordinance are severable and if any Phrase, Clause, Sentence, Paragraph or Section hereof shall be declared unconstitutional, such unconstitutionality or invalidity shall not affect any of the remaining Phrases, Clauses, Sentences, Paragraphs, or Section of this Ordinance since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional or invalid Phrase, Clause, Sentence, Paragraph, or Section.

SECTION 7. Any person violating or failing to comply with any provisions of this Ordinance shall be fined upon conviction not less than One Dollar (\$1.00) nor more than Two Hundred Dollars (\$200.00).

SECTION 8. The fact that the present ordinances and regulations of the City of Addison are inadequate to control the parking of vehicles within the corporate limits of the City of Addison, Texas, creates an emergency for the immediate preservation of public business, property, health, safety, and general welfare of the public which requires that this Ordinance shall become effective from and after the date of its passage as provided by law, and it is accordingly so ordained.
