

ORDINANCE NO. 700

AN ORDINANCE OF THE CITY OF ADDISON, TEXAS, AMENDING THE TAX ROLL FOR THE FISCAL YEAR 1978-79, AND PROVIDING FOR THE EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1. That the tax roll for the year 1978, heretofore certified by the Equalization Board, be amended as follows:

SECTION 2. That this ordinance shall take effect immediately upon its adoption, as the law in such cases provides.
