

ORDINANCE NO. 756

AN ORDINANCE OF THE CITY OF ADDISON, TEXAS, AMENDING THE TAX ROLL FOR THE FISCAL YEAR 1977-78, AND PROVIDING FOR THE EFFECTIVE DATE OF THE ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADDISON, TEXAS:

SECTION 1. That the Tax Roll for the year 1977, heretofore certified by the Equalization Board, in the assessed value of \$172,362,030 be amended as follows:
