ORDINANCE NO. 782

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING THE COMPRE-HENSIVE ZONING ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AS HERE-TOFORE AMENDED, BY AMENDING ARTICLE VIII, LOCAL RETAIL DISTRICT, TO ALLOW SAKOWITZ VILLAGE ON THE PARKWAY A VARIANCE TO SECTION 2. TO ALLOW A BUILDING OR STRUCTURE TO BE THREE (3) STORIES IN HEIGHT; TO GRANT A VARIANCE TO SECTION 5. TO ALLOW OFF-STREET PARKING SPACES TO ALSO BE HEREINDEFINED AS AN AREA MEASURING APPROXIMATELY 9' X 18'; PROVIDING FOR A PENALTY CLAUSE; PROVID-ING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

WHEREAS, application was made to amend the Comprehensive Zoning Ordinance of the City of Addison, Texas, by making application for the same with the Planning and Zoning Commission of the Town of Addison, Texas, and all the legal requirements, conditions and prerequisites having been complied with, the case having come before the City Council of Addison, Texas, after all legal notices, requirements, conditions and prerequisites having been complied with; and

WHEREAS, the City Council of the Town of Addison, Texas, does find that there is a public necessity for the zoning change, that the public demands it, that the public interest clearly requires the amendment, and it is in the best interest of the public at large, the citizens of the Town of Addison, Texas, and helps promote the general welfare and safety of this community, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That Article VIII of the Comprehensive Zoning Ordinance is hereby amended by amending Section 2. to allow a building or structure on the hereinafter described land not to exceed three (3) stories in height.

SECTION 2. That Article VIII of the Comprehensive Zoning Ordinance is hereby amended by amending Section 5. to allow off-street parking spaces to also be defined as as area measuring approximagely 9' x 18' on property hereinafter described.

SECTION 3. Said property for the above mentioned zoning variances are in the Town of Addison, Texas, and is described as follows:

BEING a tract of land out of the Allen Bledsoe Survey, Abstract No. 157, and the G.W. Fisher Survey, Abstract No. 482, and the J. Pancoast Survey, Abstract No. 1146, Town of Addison, Dallas County, Texas, and being more particularly described as follows:

BEGINNING at a point being the intersection of the east right-of-way line of Dallas Parkwav and the south right-of-way line of Belt Line Road;

THENCE East along said south line, a distance of 251.34 feet to a point for a corner;

THENCE S 65° 51' 30" E, a distance of 54.24 feet to a point for a corner;

THENCE N 48⁰ 03' 00" E, a distance of 5.0 feet to a point for a corner, said point lying on the west right-of-way line of Montfort Drive;

THENCE S 41[°] 57' 00" E along said west line, a distance of 737.45 feet to an angle point;

THENCE S 23⁰ 24' 00" E, continuing along said west line a distance of 894.98 feet to a point for a corner;

THENCE N 85[°] 31' 25" W departing said west line, a distance of 706.89 feet to an angle point;

THENCE N 85⁰ 30' 06" W a distance of 882.99 feet to a point for a corner said point lying on the east right-of-way of Dallas Parkway;

THENCE Northeasterly along said east line being a circular curve to the right having a central angle of 34° 36' 34'' and whose center bears S 88° 39' 35'' E, 1256.93 feet, an arc distance of 759.25 feet to the point of reverse curve to the left having a central angle of 36° 13' 00'' and a radius of 1014.93 feet;

THENCE Northeasterly along said curve and continuing along said east line, an arc distance of 641.54 feet to its point of tangency:

THENCE N 00° 16' 01" W, a distance of 65.52 feet to the POINT OF BEGINNING and containing 33.0231 acres of land more or less.

SECTION 4. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of the City as heretofore amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 5. That should any paragraph, sentence, subdivision, clause. phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.

SECTION 6. That all ordinances of the Citv in conflict with the provisions of this Ordinance be, and the same are hereby repealed, and all other ordinances of the city not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 7. The importance of this ordinance creates an emergency and an immerative public necessity, and the ordinance shall take effect and he in force from and after its adoption.
