- 781 Budget - Amending 1981-82 Budget.
- 782 Sakowitz Village on the Pkwy - Amending Local Retail zoning to allow a building to be three stories in height; to allow off-street parking spaces to measure 9'x18'.
- 783 Lone Star Gas Company - Franchise Ordinance.
- 784 Jimmy Dean Company - Changing the zoning located at the northeast corner of Belt Line Road and Runyon Road from Industrial to Planned Development Zoning.
- 785 Jimmy Dean Company - Special Use Permit to allow a restaurant to be located at the northeast corner of Belt Line Road and Runyon Road.
- 786 Lady Love Cosmetics - Allowing a 54 inch logo and 36 inch high accent letters located at Belt Line Road and Midway Road.
- 787 Folsom Investments - Allowing letter height of a detached sign to have a 40" logo and to allow the effective area of a detached sign to be 88 square feet.
- 788 Folsom Investments - Allowing a second monument sign located at the southwest side of Dallas Parkway and north of Westgrove Drive.
- 789 Addison Codes - Enacting new codes for the City of Addison.
- 790 Soliciting - Making it unlawful to solicit without a permit.
- 791 Garbage Collection - Increase monthly fees.
- 792 Homestead Exemption - Granting homestead exemption for residents not to exceed 40% of assessed market value of homesteads for 1982, 1983 and 1984.
- 793 Subdivision - Providing requirements for filing of subdivision plans and final plats.
- 794 Don Griffin - Granting Special Use Permit to allow mini-warehouses located on the west side of Inwood Road and south of Belt Line Road.
- 795 Forbidden City Restaurant - Special Use Permit for a restaurant and the sale of alcoholic beverages for on-premises consumption located at the southeast corner of Belt Line Road and Montfort Road.

- 796 Figaro's Restaurant - Special Use Permit for a restaurant and the sale of alcoholic beverages for on-premises consumption located at the southeast corner of Belt Line Road and Montfort Road.
- 797 Mr. Allan and David Grayson - Changing the zoning located at the northwest corner of Keller Springs and Quorum Drive from Local Retail to Commercial Zoning.
- 798 Marriott Corporation - Allowing the maximum effective area of three walls signs to be 296 square feet.
- 799 Daryl Snadon - Amendment to Local Retail Zoning to allow a building to be limited to the maximum height restrictions allowed by FAA.
- 800 First City Bank-Addison - Allowing a 19 inch high letter and a 28 inch height letter.
- 801 First City Bank-Addison - Allowing directional signs not to exceed 9 2/3 square feet in effective area.
- 802 Pelican's Restaurant - Allowing the maximum letter height for a wall sign.
- 803 Pelican's Restaurant - Allowing letter height of a pole sign not to exceed 32 inches in height.
- 804 Jimmy Dean Company - Allowing a pole sign to be 46 sq. ft. with a 23 inch high logo.
- 805 Jimmy Dean Company - Special Use Permit for a restaurant and the sale of alcoholic beverages for on-premises consumption located on the northeast corner of Belt Line Road and Runyon Road.
