

ORDINANCE NO. 084-052

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING THE CODE OF ORDINANCES OF THE TOWN OF ADDISON, TEXAS, BY AMENDING APPENDIX C, ARTICLE 1. (CABLE TELEVISION), SECTION 6., EXHIBIT 2; PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PFNALTY CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS,

SECTION 1. That the Code of Ordinance of the Town of Addison, Texas, is hereby amended by amending Appendix C, Article 1. (Cable Television), Section 6., Exhibit 2, to read as follows:

- b. Additional outlets.....\$ 5.00
- c. Installation: First outlet.....35.00
- d. Installation: Additional outlets each.....15.00
- e. Installation of pay service.....35.00
- f. Reconnections.....35.00
- g. Late payment.....5.00
- h. Public and parochial schools, colleges, and municipal buildings.

A service drop installation will be provided, on request, without charge, to a single point of entrance to a building or complex of buildings located at one geographical area, at public and parochial schools, colleges, and city buildings, which are within one hundred fifty (150) feet of a feeder line. Interior cabling and exterior distribution within a complex of buildings in a geographical area shall be provided on request at the company's cost. Should the school or city desire to provide its own exterior/interior distribution, company will render technical assistance without charge. Such installations are subject to inspection and approval by company.

- i. The company will charge an installation fee of Thirty Five dollars (\$35.00) to connect a presently existing prewired house provided the seventy-five (75) ohm system meets technical standards required by the company. As of the date of this franchise, any houses prewired for more than three (3) outlets will pay for no more than three (3) outlets according to the monthly rates. After the date of this franchise, new dwellings will be required to pay for each outlet.
- j. The company shall have provided cable availability for all Addison residents by November 28, 1984. Specifically the following addresses shall have cable availability by November 28, 1984:

- 300 through 4115 Rive Drive
- 4102, 14685, 14683, 14681 Azure Lane.

Should cable not be available to these addresses by November 28, 1984 all rate and charge increases granted in this ordinance shall be declared null and void.

1. If a person shall apply to become a subscriber within thirty (30) days of when service first comes available in his neighborhood, such person shall not be charged any installation fee as provided above; however, such free installation shall only apply to those services requested by the proposed subscriber within the said thirty day period.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of the City as heretofore amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.

SECTION 5. The effective date of this Ordinance will be August 24, 1984.
