ORDINANCE NO. 085-030

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, APPROVING AND ADOPTING AN AMENDED BUDGET FOR THE FISCAL YEAR OCTOBER 1, 1984 THROUGH SEPTEMBER 30, 1985, BY AMENDING ORDINANCE 084-070; PROVIDING THAT EXPENDITURES FOR SAID FISCAL YEAR SHALL BE MADE IN ACCORDANCE WITH SAID AMENDED BUDGET; PROVIDING FOR A REPEAL CLAUSE AND DECLARING AN EMERGENCY.
