AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING ORDINANCE NO. 083-017 SO AS TO AMEND THEIR SITE PLAN; LOCATED ON ABOUT 8.32 ACRES ON THE SOUTH SIDE OF BENT TREE PLAZA PARKWAY, BETWEEN ADDISON ROAD AND DALLAS NORTH PARKWAY; ON APPLICATION FROM TAYLOR-HEWLETT ARCHITECTS; PROVIDING FOR A PENALTY CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

WHEREAS, application was made to amend the Comprehensive Zoning
Ordinance of the Town of Addison, Texas, by making application for the same
with the Planning and Zoning Commission of the Town of Addison, Texas, as
required by State Statutes and the zoning ordinance of the Town of Addison,
Texas, and all the legal requirements, conditions and prerequisites having been
complied with, the case having come before the City Council of Addison, Texas,
after all legal notices, requirements, conditions and prerequisites having been
complied with; and

WHEREAS, the City Council of the Town of Addison, Texas, does find that there is a public necessity for the zoning change, that the public demands it, that the public interest clearly requires amendment, and it is in the best interest of the public at large, the citizens of the Town of Addison, Texas, and helps promote the general welfare and safety of this community, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That Ordinance No. 083-017 is hereby amended to add the following special conditions:

- 1. two 12 story office towers with a total of 612,740 sq. ft.,
- 2. a two story 37,000 sq. ft. retail center,
- 3. 25,000 sq. ft. of restaurant space,
- 4. the developer comply with the recommendation of their traffic study with regard to widening Addison Road south of Bent Tree Plaza Parkway prior to the issuance of a building permit for Phase II of the project,
- 5. the applicant dedicate land for the right-hand turn lane suggested by the city engineer,
- the applicant submit a detailed plan which call our specific plant material, with such plan approved by Linda Smith prior to the issuance of a building permit,
- 7. the applicant install the lighting, irrigation, and landscaping for this section of Bent Tree Plaza Parkway prior to the issuance of a Certificate of Occupancy for Phase I of the development,
- 8. the applicant provide a seventeen (17) foot wide greenway along Addison Road, with sidewalks installed within the greenway.

SECTION 2. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each day such violation shall continue to exist shall constitute a separate offense.

SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.

SECTION 4. The importance of this ordinance creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.
