AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, LEVYING THE AD VALOREM TAXES FOR THE YEAR 1985, AT A RAIF OF THIRTY-TWO CENTS (\$.32) PER ONE HUNDRED DOLLARS (\$100.00) ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY AS OF JANUARY 1, 1985; TO PROVIDE REVENUES FOR THE PAYMENT OF CURRENT EXPLOSES AND TO PROVIDE AN INTEREST AND SINKING FUND ON ALL OUTSTANDING DEBTS OF THE CITY; PROVIDING FOR DUE AND DELINGUENT TAXES TOGETHER WITH PENALTIES AND INTEREST; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS, that:

SECTION 1. That there be and is hereby levied for the tax year 1905, on all property, real and person and mixed, situated within the limits of the Town of Addison. Texas, and not exempt by the Constitution of the State and valid State Laws, a tax of thirty-two (\$.32) on each One Hundred Dollars (\$100.00) assessed value of taxable property, and shall be apportioned and distributed as follows:

⁽a) For the purpose of maintenance and operation expenses of the city tax of ten and a half (10.5) cents on each one hundred dollars (\$100.00) assessed value of all taxable property.

⁽b) For the purpose of payment of principal and interest on debt of this city a tax of twenty one and a half (21.5) cents on each one hundred dollars (\$100.00) assessed value of all taxable property.

payable on October 1, 1905, and all ad valorem shall become due and shall become delinquent after January 31, 1906. There shall be no discount for payment of taxes prior to said January 31, 1986. If any person fails to pay the ad valorem taxes on or before the Sist of January, 1986, the following penalties shall be payable thereon, to-wit:

SECTION 3. Laxos are payable in Addison, lexas, at the office of the lax Collector. The city shall have available all rights and remedies provided by law for the enforcement of the cullection of taxes levied under this ordinance.

SECTION 4. The fact that it is necessary that this ordinance be enacted in order to authorize the collection of advalorem taxes for the year 1986, creates an urgency and an emergency and requires that this ordinance shall go into effect from and after its passage, as the law in such cases provides.
