AN ORDINANCE BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS, CANVASSING RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION HELD IN SAID TOWN ON THE 14TH DAY OF SEPTEMBER, 1985; AND DECLARING AN EMERGENCY

WHEREAS, this governing body, by ordinance duly passed and adopted, made provision for a bond election to be held within this Town of the 14th day of September, 1985; and

WHEREAS, upon the consideration of the returns of said election, it appears that the same was held in accordance with the authorizing proceedings and was in all respects legally held after due notice had been given, and the said returns, duly and legally made, and other instruments, showed the following results, to wit:

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. That all the recitals contained in the preamble of this ordinance are found to be true and are adopted as findings of fact by this governing body and as part of its judgement.

Section 2. It is further found and determined that the results of the election as canvassed and tabulated in the preamble thereof reflect the expressed desires of the electors.

Section 3. That in conformity with law, this governing body is authorized to issue the bonds on behalf of said Town in the amounts and for the public improvements mentioned in the propositions set forth in the proceedings calling the election with respect to said propositions.

Section 4. That the public importance of this measure, and the fact that it is to the best interest of the Town and its citizens to provide funds for the purpose of making said permanent improvements for said Town at the earliest possible date for the immediate preservation of the public peace, health, safety and welfare of the Town and its citizens, creates an emergency and an imperative public necessity, requiring that this ordinance be passed as an emergency measure and take effect and be in full force from and after its passage, and it is so ordained.
