ORDINANCE NO. 085-101

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 9., MOTOR VEHICLES AND TRAFFIC, SECTION 9-110., STREETS OTHER THAN SCHOOL ZONES, OF THE CODE OF ORDINANCES, TOWN OF ADDISON, TEXAS, TO CHANGE THE SPEED LIMIT TO 20 MPH IN OAKS NORTH ADDITION; PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That the Code of Ordinances of the Town of Addison, Texas, are hereby amended by amending Chapter 9. Motor Vehicles and Traffic, Section 9-110, Streets Other Than School Zones, to add the following:

Section 9-110. Streets	Other Than School Zone St	reets.
Street	Extent	Speed (MPH)
Oaks North Drive	Between the 14800 block through the 14900 block of Oaks North Drive.	20
Paladium Drive	Between Montfort and Oaks North Drive, being the 14800 block of Paladium Drive.	20

SECTION 2. That all ordinances of the City in conflict with this ordinance be, and the same are hereby repealed and all other ordinances of the city not in conflict with the provisions of this ordinance shall remain in full force and effect. OFFICE OF THE CITY SECRETARY ORDINANCE NO. 085-101 SECTION 3. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.

SECTION 5. The importance of this ordinance creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.
