## ORDINANCE NO. 086-005

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 9, MOTOR VEHICLES AND TRAFFIC, SECTION 9-110., STREETS OTHER THAN SCHOOL ZONES, OF THE CODE OF ORDINANCES, TOWN OF ADDISON, TEXAS, TO CHANGE THE SPEED LIMIT TO 20 MPH ON LAKE FOREST DRIVE, WINNWOOD, CELESTIAL AND IN BELLBROOK ESTATES: PROVIDING FOR A REPEAL CLAUSE: PROVIDING FOR A PENALTY CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That the Code of Ordinances of the Town of Addison, Texas, are hereby amended by amending Chapter 9. Motor Vehicles and Traffic, Section 9-110, Streets Other Than School Zones, to add the following:

Section 9-110. Streets Other Than School Zone Streets.

Winnwood	Between the 14700 block through the 15000 block of Winn- wood.	20
Celestial	Between the 5300 block through the 5500 block of Celestial.	20
Lake Forest Dr.	Between the 14900 block through the 15000 block of Lake Forest Drive.	20

Havenshire Place	Between the 14901 block through the 14933 block of Haven- shire Place.	20
Bellbrook Dr.	Between the 14800 block through the 14925 block of Bell- brook Drive.	20

Hampton Court	Between the 14809 block through the 14818 block of Hampton Court.	20

SECTION 2. That all ordinances of the City in conflict with this ordinance be, and the same are hereby repealed and all other ordinances of the city not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.
