AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING
THE CODE OF ORDINANCES OF THE TOWN OF ADDISON, TEXAS,
AS AMENDED, BY ADDING SEC. 9-122.2, PROHIBITING PARKING
IN A PUBLIC CUL-DE-SAC PARKING AREA BETWEEN THE HOURS
OF 2:00 A.M. AND 6:00 A.M. EXCEPT AS PROVIDED IN SEC.
9-122.1; PROVIDING FOR A PENALTY NOT TO EXCEED \$200.00;
PROVIDING FOR REPEAL OF CONFLICTING SECTIONS; PROVIDING
FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That Section 9-122.2 is hereby added to Chapter 9, "Motor Vehicles and Traffic" of the Code of Ordinances of the Town of Addison, Texas, to read as follows:

Sec. 9-112.2. Same - Public Cul-de-Sac Parking Areas

(a) No stopping, standing or parking of a vehicle shall be allowed during the hours of 2:00 a.m. to 6:00 a.m., except during the moratorium granted in Sec. 9-122.1, in a Public Cul-de-sac Parking Area in the following locations:

| Street | Location |
|-----------------|-------------|
| Pokolodi Circle | 4100 block |
| Leadville Place | 4100 block |
| Rush Circle | 4100 block |
| Sopras Circle | 14800 block |

For the purpose of this section, a Public Cul-de-sac Parking Area is defined to be any designated parking area for vehicles located within a cul-de-sac of a public street.

SECTION 3. Any person, firm or corporation violating any of the provisions of this Ordinance, shall upon commission be deemed guilty of a misdemeanor, and shall be subject to a fine not to exceed the sum of Two Hundred and no/100 Dollars (\$200.00) for each offense, and each day such violation continues shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional.

SECTION 5. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 6. The fact that the present Code does not provide adequate parking regulating for cul-de-sac parking and is therefore inadequate to properly safeguard the general public, health and safety, creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force

from and after its adoption.
