

ORDINANCE NO. 086-043

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING THE SIGN ORDINANCE SO AS TO GRANT A MERITORIOUS EXCEPTION TO THE SIGN ORDINANCE TO ALLOW PENNANTS TO BE PUT UP FROM A TEMPORARY WOODEN SIGN WHICH WILL BE ATTACHED TO THE TOP SIDES OF SAID SIGN, EXTENDING TO THE GROUND; PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. In accordance with Section 8 of the Sign Ordinance a meritorious exception is hereby granted to Texas Auto Tops, located at 16301 Midway Road, and being more particularly described as follows:

A meritorious exception to Section 14-11 and Section 14-19 of the sign ordinance is hereby granted to put up pennants from a temporary wooden sign to denote their business expanding from wholesale only to retail business. The signs will be in place from Friday, May 16 (8:00 a.m.) to Sunday, May 18 (5:00 p.m.). The sign is 8'Wx8'H. The pennants will be attached to the top sides of this sign, extending to the ground.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of One Thousand Dollars (\$1000.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.

SECTION 5. The importance of this ordinance creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.
