AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING THE BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1987, BY AMENDING ORDINANCE 08 0-077; PROVIDING THAT EXPENDITURES SHALL BE MADE IN ACCORDANCE WITH SAID BUDGET: PROVIDING FOR A REPEAL CLAUSE AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS, that:

SECTION 1. That Ordinance No. 087-067 of the Town of Addison, Texas, adopting the 1986-87 fiscal budget be amended in the particulars hereinafter stated:

GENERAL FUND:

That the beginning fund balance be amended to reflect \$2,261,074.

That the City Manager's department budget be amended to appropriate an additional \$25,000 in the Special Services expenditure category and an additional \$10,000 in the Legal Services expenditure category bringing total department appropriations to \$577,619.

That the Landscape department budget be amended to appropriate an additional \$41,000 in the Water Purchase expenditure category bringing total department appropriations to \$1,046,098.

That the Planning & Health department budget be amended to appropriate an additional \$15,000 in the Office Supplies expenditure category and an additional \$15,000 in the Engineering Services expenditure category bringing total department appropriations to \$249,456.

That total expenditures be amended to reflect \$10,144,983.

That the ending fund balance be amended to reflect \$1,799,502. HOTEL FUND:

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. The importance of this ordinance creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.
