AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING SPECIAL USE ORDINANCE NO. 085-035 BY AMENDING THE SITE PLAN, ON APPLICATION FROM GREENHILL SCHOOL, LOCATED AT THE NORTHWEST CORNER OF MIDWAY ROAD AND SPRING VALLEY ROAD; PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

WHEREAS, application was made to amend the Comprehensive
Zoning Ordinance of the Town of Addison, Texas, by making
application for the same with the Planning and Zoning Commission
of the Town of Addison, Texas as required by State Statutes and

Addison, Texas, after all legal notices, requirements, conditions
and prerequisites having been complied with; and

WHEREAS, the City Council of the Town of Addison, Texas, does find that there is a public necessity for the zoning change, that the public demands it, that the public interest clearly requires the amendment, and it is in the best interest of the public at large, the citizens of the Town of Addison, and helps promote the general welfare and safety of this community, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON,
TEXAS:

SECTION 1. That Ordinance No. 085-035, passed by the City Council on the 14th day of June, 1985, is hereby amended by adding the following:

Section 2. Said property shall be improved in accordance with the development plans which are attached hereto and made a part hereof for all purposes.

SECTION 2. That Section 2 of Ordinance No. 085-035, passed by the City Council on the 14th day of June, 1985, is hereby amended to approve the attached development plans.

SECTION 3. The following special condition is placed on the land described in Ordinance No. 085-035:

- The property be platted by the applicant.

SECTION 4. That Section 2 of Ordinance No. 085-035, passed by the City Council on the 14th day of June, 1985, is hereby changed to read Section 4.

SECTION 5. That Section 3 of Ordinance No. 085-035, passed by the City Council on the 14th day of June, 1985, is hereby changed to read Section 5.

SECTION 6. That Section 4 of Ordinance No. 085-035, passed by the City Council on the 14th day of June, 1985, is hereby changed to read Section 6.

SECTION 7. That Section 5 of Ordinance No. 085-035, passed by the City Council on the 14th day of June, 1985, is hereby changed to read Section 7.

SECTION 8. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 9. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of the City as heretofore amended, and upon conviction shall be punished by a fine not to exceed the sum of One Thousand Dollars (1,000.00) and not less than Five Hundred Dollars (500.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 10. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.

SECTION 11. The importance of this ordinance creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.






