## ORDINANCE NO. 087-059

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 6.2, FOOD AND FOOD ESTABLISHMENTS, OF THE CODE OF ORDINANCES, TOWN OF ADDISON, TEXAS, PROVIDING FOR FOOD AND FOOD ESTABLISHMENTS PERMIT/LICENSE FEE, ANNUAL RENEWAL, INSPECTION, ISSUANCE, DISPLAY; PROVIDING FOR MOBILE FOOD SERVICE UNIT PERMIT FEE; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR PENALTIES; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That Chapter 6.2 of the Code of Ordinances, Town of Addison, Texas, is hereby amended by amending Sec. 6.2-1(c) to read as follows:

Sec. 6.2-1. Permit/License.

(c) Fee; annual renewal; inspection; issuance; display. A permit/license fee shall accompany each application. Permit/license fees shall be in the following amounts:

Establishments where only pre-packaged foods are sold \$ 60.00

Food Service Establishments fees are based on number of employees

l to 10 employees	\$ 75.00
11 to 30 employees	100.00
more than 30 employees	125.00

Temporary permits/licenses are valid for a maximum of three (3) consecutive days. All other permits/licenses are valid for one calendar year from date of issuance. Permits/ licenses are to be renewed on an annual basis by filing of a permit/license renewal application and fee with the regulatory authority. Applicants shall not, under any circumstances, be entitled to a refund of permit/license fee after an application has been filed. Upon receipt of new and renewal application, the regulatory authority shall make an inspection of the establishment to determine compliance with the provisions of this chapter. If the inspection reveals that the applicable requirements of this chapter have been met, a permit/license shall be issued to the applicant by the regulatory authority. All such permits must be displayed in public view. This section will become effective as of October 1, 1987.

SECTION 2. That Chapter 6.2 of the Code of Ordinances, Town of Addison, Texas, is hereby amended by amending Sec. 6.2-280 to read as follows:

Sec. 6.2-280. Fee.

The permit fee to operate a Mobile Food Service Unit within the City shall be Fifty Dollars (\$50.00) per year. This section will become effective as of October 1, 1987.

SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional.

SECTION 4. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 5. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be punished by a penalty of fine only not to exceed the sum of Four Hundred Dollars (\$400.00) for each offense, and each and every day such offense is continued shall constitute a new and separate offense.

SECTION 6. The fact that the present code of Ordinances does not provide for certain food and food establishments permits/licenses fees and is therefore, inadequate to properly safeguard the general public health and safety, creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.
