## ORDINANCE NO. 089-009

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, CALLING AND ORDERING AN ELECTION TO BE HELD IN THE TOWN OF ADDISON, ON THE 5TH DAY OF MAY, 1990, FOR THE PURPOSE OF SUBMITTING ONE PROPOSITION RELATIVE TO REMAINING OR WITHDRAWING FROM DALLAS AREA RAPID TRANSIT AUTHORITY TO QUALIFIED VOTERS OF THE TOWN OF ADDISON PROVIDING FOR THE APPOINTMENT OF ELECTION OFFICIALS; PROVIDING FOR ABSENTEE VOTING; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That the City Council, by its own initiative, hereby calls a special election to be held on Saturday, May 5, 1990, at which special election the following proposition shall be submitted to the qualified voters of the Town of Addison:

SECTION 2. Said election shall be held in accordance with the Constitution and laws of the United States and the State of Texas and the Charter of the Town of Addison, Texas, and all duly qualified electors of the Town of Addison, Texas, shall be

qualified to vote.

SECTION 3. The election shall be held at the following place in said city, and the following named person is hereby appointed officer for said election. In Election Precincts No. 1173 and 1228, at Central Fire Station, 4798 Airport Parkway, in said City, with Mark Dominic as Presiding Judge, and said Presiding Judge shall appoint the necessary clerks to assist him which shall not exceed three clerks.

SECTION 4. The polls at each of the above designated polling place shall on said election day be open from 7:00 o'clock a.m. to 7:00 o'clock p.m.

SECTION 5. Absentee voting shall be conducted by the Officer of City Secretary in Town Hall, 5300 Belt Line Road, Addison, Texas, and paper ballots shall be used for absentee voting by mail and electronic voting system shall be used for absentee voting in person.

SECTION 6. That a copy of this election ordinance and notice of special municipal election shall be mailed certified mail, postage prepaid to the Executive Committee (Directors of the Dallas Area Rapid Transit Authority who are serving as the governing body of the authority), the State Department of Highways and Public Transportation, and the Comptroller of Public Accounts.

SECTION 7. Notice of said election will be given in accordance with the terms and provisions of the Election Code and other

applicable State law, and the City Secretary is hereby instructed to have said notice posted and/or published in accordance with law.

SECTION 8. That said election shall be held in accordance with the Election Code of this State and only resident qualified voters of said City shall be eligible to vote at said election.

SECTION 9. That immediately after said election is held, the officers holding the same shall make returns of the result thereof to the Mayor of this City as required by the Election Code of this State.

SECTION 10. The terms and povisions of this ordinance shall be deemed to be severably, and if the validity of any section, subsection, sentence, clause or phrase of this ordinance should be declared to be invalid, the same shall not affect the validity of any other section, subsection, sentence, clause or phrase of this ordinance.

SECTION 11. The public importance of a special municipal election constitutes an emergency and creates a necessity for the immediate preservation of the public business, property, health and safety of the citizens of the City which requires that this ordinance be passed and take effect as an emergency measure, and it is accordingly so ordained that this ordinance shall be in full force and effect from and after its passage.
