## ORDINANCE NO. 090-036

. . .

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING SECTION 10.1-15 OF CHAPTER 10, PARKS AND RECREATION, OF THE CODE OF ORDINANCES, TOWN OF ADDISON, TEXAS, PROVIDING FOR USE RESTRICTED TO MEMBERS AND GUESTS IN ADDISON ATHLETIC CLUB AND TRINITY CHRISTIAN ATHLETIC CLUB; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR PENALTIES; AND PROVIDING FOR AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That the Code of Ordinances, Town of Addison, Texas, is hereby amended to amend Sec. 10.1-15 to read as follows:

Sec. 10.1-15. Use restricted to members and guests.

The use of the grounds, facilities and equipment of the AAC and TCAC is restricted to members of AAC and guests of such members. Only bona fide residents of the Town of Addison and their dependents aged 8 through 18 shall be eligible to become members of AAC. Employees of the Town of Addison may become conditional members of AAC upon the terms and conditions established by the Director. A person desiring to become a member must possess a valid Texas Department of Public Safety driver's license or Texas Department of Public Safety identification card which shows a current address within the corporate limits of the Town of The Director may require additional infor-Addison. mation if deemed necessary. Additionally, if the Director, in her sole discretion, deems that unusual and extraordinary circumstances exist to justify why a resident does not possess a driver's license or iden-

tification card above, then the Director may, upon presentment of a sworn statement of residency, accept such such statement and any additional information she may reasonably request as proof of residency. Birth certificates of dependent children may be requested in order to establish age.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional.

SECTION 4. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be punished by a penalty of fine only not to exceed the sum of Two hundred Dollars (\$200.00) for each offense, and each and every day such offense is continued shall constitute a new and separate offense.

SECTION 5. This ordinance shall take effect and be in force from and after its adoption and publication as provided by law.


