ORDINANCE NO. 090-043

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 3.1, ALCOHOLIC BEVERAGES, TOWN OF ADDISON, TEXAS, TO PROVIDE DEFINITIONS; TO PROVIDE FOR SPECIAL EVENTS; TO PROVIDE FOR REPEAL; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR PENALITIES; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That section 3.1-1 of the Code of Ordinances, Town of Addison, Texas, is hereby amended to read as follows:

Sec. 3.1-1. Definitions.

For the purposes of this chapter, the following terms, phrases, words and their derivations shall have the meaning given herein. When not inconsistent with the context, words used in the present tense include the future, words in the plural number include the singular number, and words in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

(a) <u>Alcoholic Beverage Code</u> or <u>Code</u> means Vernon's Texas Codes Annotated, Alcoholic Beverage Code, as amended.

(b) City or Town means the Town of Addison, Texas.

(c) <u>City Council</u> or <u>Council</u> means the city council of the Town of Addison, Texas.

(d) <u>Municipal Court</u> means the municipal court of the Town of Addison, Texas.

(e) <u>Person</u> means any person, firm, partnership, association, corporation, company or organization of any kind.

(f) <u>Special Event</u> means any event which is sponsored in whole or in part by the Town. Special Events shall include but not limited to: Airfair Addison, Founder's Day, Grand Prix, Oktoberfest and other events as designated by the City Council.

(g) <u>State License</u> means a license issued by the state or one of its agencies.

SECTION 2. That the Code of Ordinances, Town of Addison, Texas, is hereby amended by adding a section to be numbered 3.1-11, which section reads as follows:

Sec. 3.1-11. Special Events.

No person shall bring, carry or transport any alcoholic beverages as that term is defined in the Alcoholic Beverage Code into or onto any site in which a Special Event is taking place and where alcohol is being sold.

SECTION 3. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affet the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional.

SECTION 5. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be punished by a penalty of

fine not only to exceed the sum of Five Hundred and no/100 Dollars (\$500.00) for each offense, and each and every day such offense is continued shall constitute a new and separate offense.

SECTION 5. The fact that the present Code of Ordinances does not provide for standards of conduct, and therefore is inadequate to properly safeguard the general public health and safety, creates an emergency and an imperative public necessity, and the ordinance shall take effect and be in force from and after its adoption.
