

ORDINANCE NO. 090-056

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 9, MOTOR VEHICLES OF TRAFFIC, OF THE CODE OF ORDINANCES, TOWN OF ADDISON, TEXAS, RESTRICTING TRUCKS TO DESIGNATED TRUCK ROUTES, PROVIDING FOR DELIVERIES; PROVIDING FOR REPEAL; PROVIDING FOR PENALTIES; PROVIDING FOR SEVERABILITY; PROVIDING A SAVINGS CLAUSE AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That the Code of Ordinances, Town of Addison, Texas, is hereby amended to amend Sec. 9-12 to read as follows:

Sec. 9-12. Truck Routes - Restriction to Designated Routes; Exceptions.

A. No person shall operate or cause to be operated any tractor-trailer, truck-trailer, bus, trailer, semi-trailer, road trailer, pole trailer, mobile home, truck with a rated capacity in excess of one and one-half tons according to the manufacturer's classification or combination thereof upon any public street, alley, parkway, boulevard or roadway within the corporate limits except upon such streets as are designated as "Truck Routes".

B. The provisions of this section shall not apply to:

1. recreational vehicles;
2. house trailers;
3. dog trailers;
4. boat trailers;
5. vehicles operated for public service, including but not limited to those engaged in garbage pick-up, street construction, repair, or maintenance, water service, and so on;

6. vehicles used by public service utility companies engaged in installing, repairing, or maintaining public utilities; or

7. emergency vehicles operating in response to any emergency call.

C. The following streets are designated "Truck Routes" under this article:

<u>Name of Street</u>	<u>Limits</u>
Belt Line Road	Within the City limits
Midway Road	Within the City limits
Dallas North Tollway	Within the City limits
North Dallas Parkway	Within the City limits

1. The Director of Streets or such other person designated by the City Manager shall erect appropriate signs and markings to designate the Truck Routes.

2. Whenever any street designated as a Truck Route is being repaired or is otherwise temporarily out of use, the Director of Streets or such other person designated by the City Manager is hereby authorized to designate alternate Truck Routes for such period as might be necessary.

SECTION 2. That the Code of Ordinances, Town of Addison, Texas, is hereby amended to amend Sec. 9-13 to read as follows:

Sec. 9-13. Same - Deliveries.

A local commercial vehicle may leave any designated truck route and travel on any street, avenue or alley within the City for the purpose of delivering or picking up goods, wares, materials and/or merchandise or returning to its established place of business or home. When a local commercial vehicle enters a street, avenue or alley as herein permitted, such vehicle shall enter such street, avenue or alley at the intersection nearest the point of pickup or delivery or its established place of business or home and return to the truck route by the nearest route. Where more than one (1) pickup or delivery off the truck route is required, a local commercial vehicle other than a diesel-powered tractor or tractor-trailer combination shall not be required to return to the truck route after each individual pickup or delivery if the next pickup or delivery is less than one-half (1/2) mile from the preceding pickup or delivery; but, in any event, the vehicle shall return to the

truck route upon the completion of all pickups and deliveries.

SECTION 3. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional.

SECTION 5. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be punished by a penalty of fine only not to exceed the sum of Five hundred Dollars (\$500.00) for each offense, and each and every day such offense is continued shall constitute a new and separate offense.


SECTION 6. That Chapter 9, "Motor Vehicles and Traffic", of the Code of Ordinances, Town of Addison, Texas, shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 7. This ordinance shall take effect and be in force from and after its adoption and publication as provided by law.
