ORDINANCE NO. 091-029

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 14, SIGNS, OF THE CODE OF ORDINANCES, SO AS TO GRANT A MERITORIOUS EXCEPTION FOR AN ADDITIONAL MONUMENT SIGN WITH A FIFTEEN FOOT (15') SETBACK ON A PROPERTY WHICH ALREADY HAS TWO (2) MONUMENT SIGNS, ON APPLICATION WITH SERVICE INDUSTRIES PROPERTY MANAGEMENT, INC., LOCATED AT 5050 QUORUM DRIVE, PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; AND PROVIDING FOR A SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. In accordance with Section 14-118 of the Sign Ordinance a meritorious exception is hereby granted to Service Industries Property Management, Inc., to allow an additional monument sign with a fifteen foot (15') setback on a property which already has two (2) monument signs, located at 5050 Quorum Drive, on the side of the property which is adjacent to the Dallas North Tollway, in accordance with the drawings attached hereto and made a part hereof for all purposes.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.
