

ORDINANCE NO. 092-008

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING SECTION 9-70 OF CHAPTER 9, MOTOR VEHICLE AND TRAFFIC, OF THE CODE OF ORDINANCES, TOWN OF ADDISON, TEXAS; PROVIDING FOR THE TRAFFIC ENGINEER, AFTER A FINDING BY THE CITY COUNCIL THAT A PARTICULAR HAZARD EXISTS, TO ERECT STOP SIGNS.

Be it ordained by the City Council of the Town of Addison, Texas:

SECTION 1. That Chapter 9, "Motor Vehicles and Traffic" of the Code of Ordinances, Town of Addison, Texas, shall remain in full force and effect, save and accept as amended by this Ordinance.

SECTION 2. That Section 9-70 of Chapter 9 of the Code of Ordinances Town of Addison, Texas, is hereby amended to read as follows:

SECTION 9-70. Stop Signs.

The traffic engineer is hereby directed, after a finding by the City Council that a particular hazard exists, to erect stop signs requiring the driver of a vehicle to stop in accordance with state law at the following locations and any other locations as designated by the City Council:



SECTION 3. That all ordinances of the City in conflict with the provisions of this ordinance be, an the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal, or unconstitutional.

SECTION 5. This ordinance shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the Town of Addison, and it is accordingly so ordained.
