ORDINANCE NO. 093-002

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING AND REVISING ORDINANCE NO. 092-073 ORDERING AN ELECTION TO BE HELD IN THE TOWN ON JANUARY 16, 1993 FOR THE PURPOSE OF CONSIDERING CERTAIN AMENDMENTS TO THE CITY CHARTER BY AMENDING SECTION 2 RELATING TO BALLOT PROPOSITIONS AS FOLLOWS: AMENDING THE LANGUAGE IN PROPOSED AMENDMENT NO. 6 BY ADDING LANGUAGE THAT THE CITY COUNCIL RECEIVE A RECALL PETITION AND ORDER A RECALL ELECTION; RATIFYING FOR ALL PURPOSES THE LANGUAGE IN THE SAID AMENDMENT NO. 6 AS IT EXISTED ON THE BALLOT AT THE CHARTER ELECTION; AFFIRMING THE PROPOSED AMENDMENTS IN ALL OTHER RESPECTS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. Amendment. That Ordinance No. 092-073 of the Town of Addison, Texas calling and ordering an election to consider certain amendments to the City Charter is hereby amended in the following particulars, and that all other paragraphs, sentences, phrases and words of the said Ordinance are not amended but are hereby ratified, verified, approved and affirmed:

A. That Section 2 of the said Ordinance is hereby amended by amending Amendment No. 6 as set forth in Section 2 as follows:

AMENDMENT NO. 6

YES Shall the Addison City Charter be amended to provide for clarification of the procedure to be followed by the City Secretary in reviewing, for compliance with the City Charter and State law, a petition submitted under the initiative and referendum process and the process to recall a member of the Council, to require that the City

Council receive a recall petition and order a recall election, and to make such other changes as are necessary to effectuate such amendment?

SECTION 2. <u>Ratification</u>. Amendment No. 6 as stated on the official ballot for the January 16, 1993 Charter Election is hereby ratified in all respects and for all purposes.

SECTION 3. <u>Effective Date</u>. This Ordinance shall be in force and effect from and after its passage.
