

ORDINANCE NO. 093-006

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING ORDINANCE 092-014, SECTION 2, SO AS TO PROVIDE FOR A ONE-YEAR EXTENSION TO A PREVIOUSLY-APPROVED MERITORIOUS EXCEPTION TO THE CITY'S SIGN ORDINANCE TO ALLOW FOR TWO OFF-PREMISE REAL ESTATE SIGNS, ON APPLICATION WITH MICKEY MUNIR OF BELLBROOK ESTATES, LOCATED IN A CITY EASEMENT AT WINNWOOD ROAD AND BELT LINE ROAD AND AT CELESTIAL ROAD AND MONTFORT DRIVE, PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; AND PROVIDING FOR A SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That Section 2 of Ordinance 092-014, approved by the Council on February 11, 1992, in accordance with Section 14-118 of the Sign Ordinance to grant a meritorious exception to Micky Munir of Bellbrook Estates, for two off-premise real estate signs, located in a city easement on Winnwood Road and Belt Line Road and at Celestial Drive and Montfort Road, shall be amended to read as follows:

SECTION 2. That the Meritorious Exception is approved subject to the following special conditions:


-that the sign shall be removed on a date two years from the date of approval (2-11-94)

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.
