## AN ORDINANCE # 093-024

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING SECTIONS 18-76 (SEWAGE RATES) AND 18-77 (WATER RATES) OF THE TOWN OF ADDISON CODE OF ORDINANCES.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS, THAT:

SECTION 1. That Section 18-76 (Sewage rates) of the Town of Addison Code of Ordinances be amended in its entirety as shown below:

Section 18-76. Sewage rates.

The customer classifications, minimum bills, and consumption charges shall be as follows: Minimum monthly bills shall be applied to all customers based upon customer classification and shall include an allowance for volume based upon water consumed as follows:

Customer Classification	Minimum Monthly Bill	Volume Included
Single-Family Residential	\$ 10.10	2,000 gallons
Multi-Family Residential	\$ 57.65	15,000 gallons
Municipal / Schools	\$ 76.00	20,000 gallons
Commercial Large (meter size greater than or equal to 2 inches)	\$ 138.15	37,000 gallons
Commercial Small (meter size less than 2 inches)	\$17.71	3,000 gallons
Industrial Large (meter size greater than or equal to 2 inches)	\$295.55	80,000 gallons
Industrial Small (meter size less than 2 inches)	\$13.75	3,000 gallons
Hotel/Motel	\$295.55	80,000 gallons

All volume which exceeds the amount allowed in the minimum bill will be charged at a rate of \$3.67 per 1,000 gallons of water consumed for all customer classifications. Single-family residential customers will not be charged for volume which exceeds 10,000 gallons of water consumed.

No sewage charges will be levied for separately metered water for air-conditioning of sprinkler units where none of the water is returned to the sewage system. In the event that a customer believes their business uses considerable quantities of water which are not returned to the sewage system, they may at their expense under the city's specifications, construct a sewage meter to determine the exact amount of sewage discharged. Sewage rates will be charged based upon the actual sewage flow rather than the water usage.

SECTION 2. That Section 18-77 (Water rates) of the Town of Addison Code of Ordinances be amended in its entirety as shown below:

Section 18-76. Water rates.

The customer classifications, minimum bills, and consumption charges shall be as follows:

Minimum monthly bills shall be applied to all customers based upon customer classification and shall include an allowance for volume based upon water consumed as follows:

Customer Classification	Minimum Monthly Bill	Volume Included
Single-Family Residential	\$ 7.35	2,000 gallons
Multi-Family Residential	\$ 44.35	15,000 gallons
Municipal / Schools	\$ 58.40	20,000 gallons
Commercial Large (meter size greater than or equal to 2 inches)	\$ 107.35	37,000 gallons
Commercial Small (meter size less than 2 inches)	\$10.40	3,000 gallons
Industrial Large (meter size greater than or equal to 2 inches)	\$235.95	80,000 gallons
Industrial Small (meter size less than 2 inches)	\$9.50	3,000 gallons
Hotel/Motel	\$235.55	80,000 gallons
Sprinkler Large (meter size greater than or equal to 2 inches)	\$73.84	27,000 gallons
Sprinkler Small (meter size less than 2 inches)	\$15.20	5,000 gallons
Fire Meters	\$24.10	8,000 gallons

All volume which exceeds the amount allowed in the minimum bill will be charged at a rate of \$1.47 per 1,000 gallons of water consumed for all customer classifications.

SECTION 3. This ordinance shall take affect with the first billing period of October, 1993.
