**AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS,  
PROVIDING FOR THE RELINQUISHMENT OF A RIGHT-  
OF-WAY DEDICATION OF LIBERTY BOULEVARD AS  
SHOWN ON THE FINAL PLAT OF THE SUNBELT  
CORPORATE HEADQUARTERS ADDITION, TOWN OF  
ADDISON, DALLAS COUNTY, TEXAS; PROVIDING FOR  
RECORDATION OF THIS ORDINANCE; AND PROVIDING  
FOR AN EFFECTIVE DATE**

WHEREAS, the City Council of the Town of Addison is of the opinion that the right-of-way dedication described herein is not needed for public use, and the same should be relinquished, vacated, and abandoned; and

WHEREAS, the City Council of Town of Addison is of the opinion that the interest and welfare of the public will be served by this Ordinance;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

**SECTION 1.**

- (a) The Town of Addison does hereby relinquish, vacate, and abandon that certain right-of-way dedication more particularly described as follows:

Variable Width Access Easement  
shown as Liberty Boulevard on the  
Final Plat of the Sunbelt Corporate  
Headquarters Addition, Town of  
Addison, Dallas County, Texas, said  
Plat approved by City Council on  
December 4, 1984 and recorded at  
Volume 86234, Page 74712, Map  
Records, Dallas County, Texas

- (b) This Ordinance shall not relinquish any utility easements, public or private, within Liberty Boulevard.

**SECTION 2.** The relinquishment provided for herein shall extend only to the public right, title, easement and interest, if any, in the right-of-way described herein; and shall be construed to extend only to that interest, if any, of the City Council of the Town of Addison may lawfully relinquish, vacate and abandon.

**SECTION 3.** The City Secretary is hereby authorized and directed to certify and record a copy of this Ordinance in the Real Property Records of Dallas County, Texas.

SECTION 4. This Ordinance shall take effect immediately from and after its passage.
