## ORDINANCE NO. 094-013

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING CHAPTER 9, MOTOR VEHICLES AND TRAFFIC, OF THE CODE OF ORDINANCES OF THE CITY BY ADDING A NEW SECTION 9-122.3 PROHIBITING THE PARKING OF VEHICLES BETWEEN THE HOURS OF 2:00 A.M. AND 5:00 A.M. IN ADDISON PUBLIC FACILITIES, INCLUDING THE ADDISON TOWN HALL, TOWN FINANCE BUILDING, ADDISON SERVICE CENTER, ADDISON ATHLETIC CLUB, AND ALL ADDISON PARK FACILITIES; PROVIDING DEFINITIONS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

- 1. <u>Amendments</u>. Chapter 9, Motor Vehicles and Traffic, of the Code of Ordinances of the City is hereby amended as set forth in Exhibit "A" attached hereto and by reference made a part hereof for all purposes.
- 2. <u>Severability</u>. If any part or provision of this Ordinance or application thereof to any person or circumstance is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.
- 3. <u>Savings, Repealer</u>. This Ordinance shall be cumulative of all other ordinances of the City affecting the parking and standing of vehicles and shall not repeal any of the provisions of those ordinances except in those instances where provisions of those ordinances are in direct conflict with the provisions of this Ordinance.
- 4. <u>Effective Date</u>. This Ordinance shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the Town of Addison.

## EXHIBIT "A"

## AMENDMENTS TO CHAPTER 9, MOTOR VEHICLES AND TRAFFIC, CODE OF ORDINANCES TOWN OF ADDISON, TEXAS

A new Section 9-122.3 to Chapter 9 of the Code of Ordinances is hereby added to read as follows:

Section 9-122.3. Overnight parking in public facilities.

(a) Definitions. For purposes of this Section, the term "public facilities" shall mean and include the following facilities and property (all locations designated herein are locations within the City):

Addison Town hall, being that property located at 5300 Belt Line Road.

Addison Athletic Club, being that property located at 3900 Beltway Drive.

Addison Finance Building, being that property located at 5350 Belt Line Road.

Addison Service Center, being that property located at 16801 Westgrove Road.

Park property, meaning and including any park, athletic facility, reservation, playground, recreation center or any other area in the city, owned or used by the city and devoted to active or passive recreation and including, but not limited to, the Town Park (located south of Sidney Drive and west of Woodway Drive), Celestial Park (located at the intersection of Celestial Road and Bellbrook Drive), Quorum Park (located on Quorum Drive north of Keller Springs Road, and the Addison easement trail.

(b) Overnight parking prohibited. No person shall stand or park any vehicle in, along or upon any public facilities between the hours of 2:00 A.M. and 5:00 A.M. This prohibition shall not be applicable to any vehicle which is being used for emergency purposes, to the operation of any vehicle being used by a utility company for repair purposes, or to any governmental vehicle being used for necessary governmental purposes.
