ORDINANCE NO. 094-020

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING SPECIAL USE ORDINANCE NO. 091-035 BY AMENDING THE SITE PLAN TO ADD A PATIO DINING AREA, ON APPLICATION WITH THE FILLING STATION RESTAURANT, LOCATED AT 15201 ADDISON ROAD; PROVIDING FOR SPECIAL CONDITIONS; PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; AND PROVIDING FOR A (or NO) SEVERABILITY CLAUSE.

WHEREAS, application was made to amend the Comprehensive Zoning Ordinance of the Town of Addison, Texas, by making application for the same with the Planning and Zoning Commission of the Town of Addison, Texas, as required by State Statutes and the zoning ordinance of the Town of Addison, Texas, and all the legal requirements, conditions and prerequisites having been complied with, the case having come before the City Council of Addison, Texas, after all legal notices, requirements, conditions and prerequisites having been complied with; and

WHEREAS, the City Council of the Town of Addison, Texas, does find that there is a public necessity for the zoning change, that the public demands it, that the public interest clearly requires the amendment, and it is in the best interest of the public at large, the citizens of the Town of Addison, and helps promote the general welfare and safety of this community, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That Ordinance No. 091-035 passed by the City Council on the 9th day of July, 1991, is hereby amended by amending Section 2, Paragraph 1 to read as follows:

1. That prior to the issuance of a Certificate of Occupancy for the expanded restaurant, said property shall be improved in accordance with the development plans for the additional patio area, which are attached hereto and made a part hereof for all purposes.

SECTION 2. That Ordinance No. 091-035 passed by the City Council on the 9th day of July, 1991, is hereby amended by amending Section 2, Paragraph 2 to read as follows:

2. That the Special Use Permit granted herein shall be limited to a restaurant and the sale of alcoholic beverages for on-premises consumption only and to that particular area designated on the final site plan as encompassing a total area not to exceed 3,904 square feet.

SECTION 3. That the amendments to the Special Use Permits on application from the Filling Station are approved subject to the following special conditions:

-The storage building addition shall be built out of brick to match the restaurant building, and screened from Addison Road by landscaping.

-The applicant shall construct the deck with special attention to the existing trees shown in the deck area.

-The applicant shall submit a detailed landscaping plan and a revised irrigation plan as a part of the building permit set of plans.

-The new railing around the patio shall match the existing railing on the handicapped ramp.

SECTION 4. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 5. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject OFFICE OF THE CITY SECRETARY ORDINANCE NO. 094-020 to the same penalty as provided for in the Comprehensive Zoning Ordinance of the city, as heretofore amended, and upon conviction shall be punished by a fine set in accordance with Chapter 1, General Provisions, Section 1.10, General penalty for violations of Code; continuing violations, of the Code of Ordinances for the Town of Addison.

SECTION 6. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.
