## ORDINANCE NO. 094-037

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING CHAPTER 9, MOTOR VEHICLES AND TRAFFIC, OF THE CODE OF ORDINANCES OF THE CITY BY AMENDING SECTION 9-69 RELATING TO THE LOCATION OF TRAFFIC CONTROL SIGNALS BY ADDING ADDITIONAL LOCATIONS FOR THE PLACEMENT OF SUCH SIGNALS AS SET FORTH HEREIN; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

1. <u>Amendments</u>. Chapter 9, Motor Vehicles and Traffic, of the Code of Ordinances of the City is hereby amended as set forth in Exhibit "A" attached hereto and by reference made a part hereof for all purposes.

2. <u>Severability</u>. If any part or provision of this Ordinance or application thereof to any person or circumstance is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

3. <u>Savings, Repealer</u>. This Ordinance shall be cumulative of all other ordinances of the City affecting the parking and standing of vehicles and shall not repeal any of the provisions of those ordinances except in those instances where provisions of those ordinances are in direct conflict with the provisions of this Ordinance.

4. <u>Effective Date</u>. This Ordinance shall take effect immediately from and after its passage in accordance with the provisions of the Charter of the Town of Addison.

## EXHIBIT "A"

## AMENDMENTS TO CHAPTER 9, MOTOR VEHICLES AND TRAFFIC, CODE OF ORDINANCES TOWN OF ADDISON, TEXAS

Section 9-69 is hereby amended by amending paragraph (b) thereof by adding Mildred Street to the list of streets on which the stopping, standing and parking of vehicles is permits, so that it shall hereafter read as follows (asterisks (\*) represent text of the Code which is not amended hereby and which is not reproduced herein; additions are indicated by <u>underlining</u>; deletions are indicated by <u>strike through</u>):

## Sec. 9-69. Location of signals.

The traffic engineer is hereby authorized and directed to place a traffic control signal exhibiting different colored lights successively one at a time in accordance with state law at the following locations:
