ORDINANCE NO. 094-081

AN ORDINANCE BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS, REGULATING AND PRESCRIBING THE RATES TO BE CHARGED BY TCI FOR THE BASIC SERVICE TIER; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with applicable FCC regulations, on or about November 9, 1993, the City passed and adopted an Ordinance providing for the regulation of rates charged by cable television operators within the City for basic service tier and related equipment and installation charges and providing for a reasonable opportunity for interested parties to express views concerning basic cable regulation; and

WHEREAS, on or about the 15th day of August, 1994, TCI filed its proposed rate schedule with the City Secretary based upon the FCC's Form 1200 Series; and

WHEREAS, on the 13th day of September, 1994, the City Council of the Town of Addison, Texas, duly passed Resolution No. R94-065 which suspended the service rates proposed by TCI for a period of 90 days in accordance with FCC Regulation Section 76.933; and

WHEREAS, the rates proposed to be charged by TCI have been reviewed by the City's consultant First Southwest Company and a recommendation made thereon; and

WHEREAS, the rates proposed by TCI are determined to be in the public interest; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:
