ORDINANCE NO. 095-025

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 16, DIVISION 2 CONSTRUCTION, SECTION 16-63, OF THE CODE OF ORDINANCES OF THE TOWN OF ADDISON, TEXAS, REGULATING THE HOURS DURING WHICH INTERFERENCE WITH THE TRAFFIC FLOW WILL BE PERMITTED ON BELT LINE ROAD AND MIDWAY ROAD; PROVIDING FOR PENALTIES; PROVIDING FOR REPEAL; AND PROVIDING FOR SEVERABILITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. That the Code of Ordinances of the Town of Addison, Texas, is hereby amended to amend Chapter 16, Division 2, Section 16-63, to read as follows:

Sec. 16-63 Routing of Traffic

a) The permittee shall take appropriate measures to assure that during the performance of the excavation work, traffic conditions as nearly normal as practicable shall be maintained at all times so as to cause little inconvenience as possible to occupants of abutting property and to the general public, provided that the director of streets may permit the closing of streets to all traffic for a period of time prescribed by him if, in his opinion, it is necessary. No interference with traffic flow on city streets shall be permitted during the hours of 6:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mondays through Fridays.

No interference with traffic flow on Belt Line Road and Midway Road will be permitted during the hours of;

6:00 a.m. to 10:00 p.m. Mondays through Thursdays

6:00 a.m. Fridays through 3: a.m. Saturdays

9:00 a.m. Saturdays through 3:00 a.m. Sundays

9:00 a.m. Sundays through 10 p.m. Sundays

RUBLISHED 6-22-95

Contractors working for the City on contracts awarded by Council prior to May 23, 1995, are exempt from Belt Line Road and Midway Road time restrictions.

SECTION 2. Any person, firm, or corporation violating any of the provisions of this Ordinance, shall upon commission be deemed guilty of a misdemeanor, and shall be subject to a fine not to exceed the sum of Two Hundred and no/100 Dollars (\$200.00) for each offense, and each day such violation continues shall constitute a separate offense.

SECTION 3. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed, and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 4. That should any paragraph, subdivision, clause, phrase or section of this ordinance be adjudged or be held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof other than the part so decided to be invalid, illegal, or unconstitutional.
