ORDINANCE NO. 095–056

AN ORDINANCE OF THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS PROVIDING FOR THE ABANDONMENT OF A PORTION OF A DRAINAGE AND UTILITY EASEMENT LOCATED IN THE BACK OF THE PROPERTY LOCATED AT 14798 LOCHINVAR COURT, ADDISON, TEXAS PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the Town of Addison, Texas, acting pursuant to law, deems it advisable to abandon a portion of its drainage and utility easement described herein which is not needed for a public use, and said described property should be abandoned, relinquished, and vacated; and

WHEREAS, the City Council of the Town of Addison, Texas is of the opinion that the best interest and welfare of the public is served by abandoning same.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. The Town of Addison does hereby abandon, relinquish, and vacate that portion of the drainage and utility easement as described in Exhibit "A" attached hereto and made a part hereof for all purposes.

Section 2. The abandonment provided herein shall only apply to the public right, title, easement and interest, if any, of the Town of Addison may lawfully abandon, vacate and relinquish.

Section 3. That the City Secretary is hereby directed to certify a copy of this ordinance and cause it to be recorded in the Deed Records of Dallas County, Texas.

Section 4. That this ordinance shall take effect immediately upon passage and it is so ordained.



Thence South 0 degrees 14 minutes 28 seconds east for a distance of 3 feet to the South line of a 5 foot drainage casement;


