AN ORDINANCE OF THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS PROVIDING FOR THE ABANDONMENT OF A PORTION OF A DRAINAGE AND UTILITY EASEMENT LOCATED ALONG THE NORTHWEST PROPERTY LINE OF THAT PROPERTY LOCATED AT 14572 WATERVIEW CIRCLE ADDISON, TEXAS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the Town of Addison, Texas, acting pursuant to law, deems it advisable to abandon a portion of its drainage and utility easement described herein which is not needed for a public use, and said described property should be abandoned, relinquished, and vacated; and

WHEREAS, the City Council of the Town of Addison, Texas is of the opinion that the best interest and welfare of the public is served by abandoning same.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

- Section 1. The Town of Addison does hereby abandon, relinquish, and vacate that portion of the ten (10) foot drainage and utility easement as described and depicted in Exhibit "A" attached hereto and made a part hereof for all purposes, which drainage and utility easement is located on and adjacent to the northwest property line of Lot 8, Block A of Waterview Estates, and Addition to the Town of Addison in Dallas County, Texas, according to the Revised Map thereof recorded in Volume 92006, Page 1954, Map Records, Dallas County, Texas, and which property is more generally described as 14572 Waterview Circle, Addison, Texas.
- Section 2. The abandonment provided herein shall only apply to the public right, title, easement and interest, if any, which the Town of Addison may lawfully abandon, vacate and relinquish.
- Section 3. The City Secretary is hereby directed to certify a copy of this Ordinance and cause it to be recorded in the Deed Records of Dallas County, Texas.
- Section 4. This Ordinance shall take effect immediately upon passage and it is so ordained.



