#### ORDINANCE NO. 096-008

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS DECLARING ELECTED TO THE OFFICE OF CITY COUNCIL MEMBER THE UNOPPOSED CANDIDATES FOR ELECTION TO THAT OFFICE; PROVIDING THAT SUCH ELECTION SHALL BE EFFECTIVE AS OF MAY 4, 1996, AND THAT SUCH CANDIDATES SHALL TAKE THEIR OFFICE AS PROVIDED FOR BY LAW; PROVIDING THAT THE MAY 4, 1996 GENERAL ELECTION SHALL NOT BE HELD; PROVIDING THAT A COPY OF THIS ORDINANCE SHALL BE POSTED ON ELECTION DAY AT EACH POLLING PLACE THAT WOULD HAVE BEEN USED IN THE ELECTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with Subchapter C of Chapter 2 of the Texas Election Code, the City Council of the Town of Addison has received from the City Secretary her written Certification that the three candidates for election to the office of City Council member are unopposed for election to that office (a true and correct copy of the Certification is attached hereto and incorporated herein).

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. <u>Incorporation of premises</u>. The above and foregoing premises are true and correct and are incorporated herein in their entirety.

Section 2. <u>Declaration of election</u>. The following candidates for election to the office of City Council member are hereby declared elected to that office:

## ANN SUDDUTH BOB DOEPFNER GREG ROACH

Such election shall be effective as of May 4, 1996. The elected candidates shall take their office in accordance with law, and a certificate of election shall be issued to each candidate in the same manner as provided for a candidate elected at a general election.

Section 3. <u>General election not held</u>. The May 4, 1996 election shall not be held.

Section 4. <u>Posting of ordinance</u>. A true and correct copy of this Ordinance shall be posted on May 4, 1996 by the City Secretary at each polling place that would have been used in the general election.

### TOWN OF ADDISON, TEXAS 1996 GENERAL ELECTION

#### **CERTIFICATION OF UNOPPOSED STATUS**

1. On February 27, 1996 the City Council of the Town of Addison, Texas adopted Ordinance No. 096-008 calling an election to be held on May 4, 1996 for the purpose of electing three (3) persons to the office of Council member.

2. As set forth in the Ordinance and in accordance with Section 143.007 of the Texas Election Code (the "Code"), persons desiring to have their name placed on the election ballot were required to file with the City Secretary the person's sworn application not earlier than February 19, 1996 and not later than 5:00 P.M. on March 20, 1996. During that period of time, the only applications for a place on the ballot filed with the City were from the following persons:

3. In addition to persons desiring to have their name placed on the ballot, persons desiring to declare themselves as a write-in candidate were required to file with the City Secretary a declaration of such candidacy on or before 5:00 P.M. on March 20, 1996. No such declarations were filed.

4. The purpose of the election being to elect three (3) persons to the office of Council member and there being only three candidates for that election, only one (1) candidate's name would be placed on the ballot for each office.

5. No proposition is to appear on the May 4, 1996 election ballot.

THEREFORE, pursuant to the above and in accordance with Section 2.052 of the Code, I do hereby certify to the City Council of the Town of Addison, Texas that the following persons are unopposed for election to the office of City Council member:
