ORDINANCE NO. 097- 011

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS DECLARING ELECTED TO THE OFFICE OF MAYOR AND OF CITY COUNCIL MEMBER THE UNOPPOSED CANDIDATES FOR ELECTION TO THAT OFFICE; PROVIDING THAT SUCH ELECTION SHALL BE EFFECTIVE AS OF MAY 3, 1997, AND THAT SUCH CANDIDATES SHALL TAKE THEIR OFFICE AS PROVIDED FOR BY LAW; PROVIDING THAT THE MAY 3, 1997 GENERAL ELECTION SHALL NOT BE HELD; PROVIDING THAT A COPY OF THIS ORDINANCE SHALL BE POSTED ON ELECTION DAY AT EACH POLLING PLACE THAT WOULD HAVE BEEN USED IN THE ELECTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with Subchapter C of Chapter 2 of the Texas Election Code, the City Council of the Town of Addison has received from the City Secretary her written Certification that the one candidate for election to the office of Mayor, the three candidates for election to the office of Council member for two year terms each, and the one candidate for election to the office of Council member for a one year unexpired term, are unopposed for election to those respective offices (a true and correct copy of the Certification is attached hereto and incorporated herein).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. Incorporation of premises. The above and foregoing premises are true and correct and are incorporated herein in their entirety.

Section 2. Declaration of election. The following candidates for election to the offices of Mayor and of Council member, as set forth below, are hereby declared elected to that office:

For the Office of Mayor

RICH BECKERT

For the Office of Council Member (two year term)

MARY DOLAN
SUSAN HALPERN
R. SCOTT WHEELER

For the Office of Council Member (one year unexpired term)

FRANK KLEIN


Such election shall be effective as of May 3, 1997. The elected candidates shall take their office in accordance with law, and a certificate of election shall be issued to each candidate in the same manner as provided for a candidate elected at a general election.

Section 3. General election not held. The May 3, 1997 election shall not be held.

Section 4. Posting of ordinance. A true and correct copy of this Ordinance shall be posted on May 3, 1997 by the City Secretary at each polling place that would have been used in the general election.

Section 5. Effective date. This Ordinance shall be in full force and effect from and after its passage.



1997 GENERAL ELECTION**

CERTIFICATION OF UNOPPOSED STATUS

1. On February 11, 1997 the City Council of the Town of Addison, Texas adopted Ordinance No. 097-005 calling an election to be held on May 3, 1997 for the purpose of electing one (1) person to the office of Mayor for a two year term, three (3) persons to the office of Council member for two (2) year terms each, and one (1) person to the office of Council member for a one (1) year unexpired term.

2. As set forth in the Ordinance and in accordance with Section 143.007 of the Texas Election Code (the "Code"), persons desiring to have their name placed on the election ballot were required to file with the City Secretary the person's sworn application not earlier than February 17, 1997 and not later than 5:00 P.M. on March 19, 1997. During that period of time, the only applications for a place on the ballot filed with the City were from the following persons:

For the Office of Mayor

RICH BECKERT

For the Office of Council Member (two year term)

MARY DOLAN
SUSAN HALPERN
R. SCOTT WHEELER

For the Office of Council Member (one year unexpired term)

FRANK KLEIN

3. In addition to persons desiring to have their name placed on the ballot, persons desiring to declare themselves as a write-in candidate were required to file with the City Secretary a declaration of such candidacy on or before 5:00 P.M. on March 19, 1997. No such declarations were filed.

4. The purpose of the election being to elect one (1) person to the office of Mayor for a two year term, three (3) persons to the office of Council member for two (2) year terms each, and one (1) person to the office of Council member for a one (1) year unexpired term, and there being only one candidate for the office of Mayor, three candidates for the office of Council member for a two year term, and one candidate for the office of Council member for a one year unexpired term, only one (1) candidate's name would be placed on the ballot for each office.

5. No proposition is to appear on the May 3, 1997 election ballot.

THEREFORE, pursuant to the above and in accordance with Section 2.052 of the Code, I do hereby certify to the City Council of the Town of Addison, Texas that the following persons are unopposed for election to the office of City Council member:


