

**ORDINANCE NO. 000-007**  
**AN ORDINANCE CANVASSING RETURNS AND DECLARING THE**  
**RESULTS OF A BOND ELECTION HELD IN THE TOWN OF**  
**ADDISON ON FEBRUARY 12, 2000**

WHEREAS, the City Council (the "City Council") of the Town of Addison (the "Town"), by ordinance duly passed and adopted, made provision for an election (the "Election") to be held within the City on February 12, 2000, for the purpose of submitting certain propositions for the issuance of general obligation bonds to the resident qualified electors of the City; and

WHEREAS, upon the consideration of the returns of the Election, it appears that the same was held in accordance with the authorizing proceedings and was in all respects legally held after due notice had been given, and the returns duly and legally made, and other instruments, showed the following results:

THE ISSUANCE OF \$725,000 GENERAL OBLIGATION BONDS FOR CONSTRUCTING A COMMUNITY OUTDOOR SWIMMING POOL AND RELATED FACILITIES AND THE LEVY OF A TAX IN PAYMENT THEREOF	VOTES FOR:	285
	VOTES AGAINST:	125

TOTAL BALLOTS CAST IN ELECTION: 414

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS, THAT:

Section 1. All of the recitals contained in the preamble of this Ordinance are found to be true and are adopted as findings of fact by the City Council and as part of its judgment.

Section 2. It is further found and determined that the results of the Election as canvassed and tabulated in the preamble hereof reflect the expressed desires of the electors.



PASSED AND APPROVED BY the City Council of the Town of Addison this February 15, 2000.




