

ORDINANCE NO. 000- 008

AN ORDINANCE OF THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS AMENDING CHAPTER 26 ("COURTS") BY AMENDING SECTION 26-47(C) RELATING TO THE EXPENDITURE OF THE MUNICIPAL COURT BUILDING SECURITY FUND AS SET FORTH HEREIN; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. Amendment. Section 26-47(c) of Chapter 26 ("Courts") of the Code of Ordinances of the Town of Addison, Texas is hereby amended as follows, and all other chapters, sections, subsections, paragraphs, sentences, phrases and words of the said Code are not amended but are hereby ratified, verified, approved and affirmed:

**"Sec. 26-47. Building security costs.**

(c) *Deposit of fee into the fund; fund administration; use of fee.* The court clerk shall collect the security fee, pay the fee to the finance director, and the fee shall be deposited by the finance director into the fund. The fund shall be administered under the direction of the city council. The fund may be used only to finance ~~the following~~ items when used for the purpose of providing security services for the municipal court of record, as appropriate, including:


- (1) the purchase of or repair of x-ray machines and conveying systems;
- (2) handheld metal detectors;
- (3) walk-through metal detectors
- (4) identification cards and systems;
- (5) electronic locking and surveillance equipment;
- (6) bailiffs, deputy sheriffs, deputy constables, or contract security personnel during times when they are providing appropriate security services;
- (7) signage;
- (8) confiscated weapon inventory and tracking systems;
- (9) locks, chains, alarms, or similar security devices ~~or other hardware~~;
- (10) the purchase or repair of bullet-proof glass; and
- (11) continuing education on security issues for court personnel and security personnel."

Section 2. Severability. The sections, paragraphs, sentences, phrases, clauses and words of this Ordinance are severable, and if any section, paragraph, sentence, phrase, clause or word in this Ordinance or application thereof to any person or circumstance is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares that it would have passed such remaining portions of

this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.


Section 3. Effective date. This Ordinance shall become effective from and after its date of passage as provided by law.
