## **ORDINANCE NO. 003-021**

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 62, SIGNS, OF THE CODE OF ORDINANCES, SO AS TO GRANT A MERITORIOUS EXCEPTION TO THE TOWN'S SIGN ORDINANCE TO ALLOW A 41 SQUARE FEET ATTACHED BUILDING SIGN WITH LETTERS 30 INCHES IN HEIGHT TO BE LOCATED ON THE SOUTHEAST FACADE AND AN ADDITIONAL MONUMENT SIGN ON DALLAS PARKWAY WITH AN AREA OF 72 SQUARE FEET AND 8 FEET IN HEIGHT, ON APPLICATION WITH TWO ROWS RESTAURANT AND BREWERY, LOCATED AT 17225 DALLAS PARKWAY, PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; AND PROVIDING FOR A SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. In accordance with Section 62-163, Section 62-183 and Section 62-186 of the Sign Ordinance, a meritorious exception is hereby granted to Two Rows Restaurant & Brewery at 17225 Dallas Parkway, Addison, Texas, to allow a 41 square feet attached building sign with letters 30 inches in height on the southeast façade and an additional monument sign on Dallas Parkway with an area of 72 square feet and 8 feet in height, in accordance with the drawings attached hereto and made a part hereof for all purposes.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or

provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.






