TOWN OF ADDISON, TEXAS ORDINANCE NO. 008-004

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, AMENDING CHAPTER 62, SIGNS, OF THE CODE OF ORDINANCES, SO AS TO GRANT A MERITORIOUS EXCEPTION TO THE CITY'S SIGN ORDINANCE TO ALLOW AN ATTACHED TOM THUMB SIGN WITH LETTER HEIGHTS OF 68" AND 24"AND AN AREA OF 200 SQUARE FEET, AN ATTACHED PHARMACY SIGN WITH LETTER HEIGHTS OF 30" AND A LOGO HEIGHT OF 39" AND AN AREA OF 47 SQUARE FEET, AN ATTACHED STARBUCKS COFFEE SIGN WITH LETTER HEIGHTS OF 14" AND AN AREA OF 22 SQUARE FEET AND AN ATTACHED SIGNATURE CAFÉ SIGN WITH A LOGO HEIGHT OF 24" AND AN AREA OF 20 SQUARE FEET ON APPLICATION WITH TOM THUMB, LOCATED AT 14280 MARSH LANE, PROVIDING FOR A REPEAL CLAUSE; PROVIDING FOR A PENALTY CLAUSE; AND PROVIDING FOR A SEVERABILITY CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

SECTION 1. In accordance with Chapter 62-162 and Chapter 62 - 163 of the Sign Ordinance a meritorious exception is hereby granted to Tom Thumb, located at 14280 Marsh Lane, to allow an attached Tom Thumb sign with letter heights of 68" and 24" and an area of 200 square feet, an attached Pharmacy sign with letters heights of 30" and a logo height of 39" and an area of 47 square feet, an attached Starbucks Coffee sign with letters 14" in height and an area of 22 square feet and a Signature Café sign with a logo height of 24" and an area of 20 square feet in accordance with the drawings attached hereto and made a part hereof for all purposes.

SECTION 2. That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

SECTION 3. That any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to a fine not to exceed the sum of Two

Hundred Dollars (\$200.00) for each offense and that each day such violation shall continue to exist shall constitute a separate offense.

SECTION 4. That should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provisions thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of this ordinance as a whole.




