## ORDINANCE NO. 011-051

AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS AMENDING THE TOWN'S CODE OF ORDINANCES BY AMENDING CHAPTER 2 (ADMINISTRATION), ARTICLE III (OFFICERS AND EMPLOYEES), DIVISION 2 (CODE OF ETHICS), SECTION 2-93 (STANDARDS OF CONDUCT) THEREOF BY AMENDING SUBSECTION (11) OF SECTION2-93 REGARDING USE OF OFFICIAL POSITION BY PROVIDING AN EXCEPTION THERETO FOR THE PROMOTION OF BUSINESSES AND ECONOMIC DEVELOPMENT WITHIN THE TOWN; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. <u>Amendment</u>. The Code of Ordinances of the Town of Addison, Texas ("<u>City</u>") is hereby amended by amending Chapter 2 (Administration), Article III (Officers and Employees), Division 2 (Code of Ethics) thereof as set forth below, and no other chapters, articles, divisions, sections, paragraphs, sentences, phrases or words of the said Code of Ordinances are amended hereby:

A. Section 2-93(11) of the said Code of Ordinances is amended so that it shall hereafter read as follows (additions are <u>underlined</u>; deletions are <u>struck-through</u>; where asterisks (\*\*\*\*\*) are used, the same represents text of a section that is not included herein and is not amended or modified by this Ordinance):

## Section 2-93. Standards of conduct.

Section 2. <u>Savings</u>; <u>Repealer</u>. This Ordinance shall be cumulative of all other ordinances of the City and shall not repeal any of the provisions of those ordinances except in

those instances where the provisions of those ordinances are in direct conflict with the provisions of this Ordinance.

Section 3. <u>Severability</u>. The provisions of this Ordinance are severable, and if any section or provision of this Ordinance or the application of any section or provision to any person, firm, corporation, entity, situation or circumstance is for any reason adjudged invalid or held unconstitutional by a court of competent jurisdiction, the same shall not affect the validity of any other section or provision of this Ordinance or the application of any other section or provision to any other person, firm, corporation, entity, situation or circumstance, and the City Council declares that it would have adopted the valid portions of this Ordinance adopted herein without the invalid or unconstitutional parts and to this end the provisions of this Ordinance adopted herein shall remain in full force and effect.

Section 4. <u>Effective Date</u>. This Ordinance shall become effective from and after its passage and approval.
