

**NOTES: PEDESTRIAN CROSSING**

**BASE BID SHALL INCLUDE THE FOLLOWING:**

1. POWER WASH AND CLEAN EXISTING CONCRETE ACCORDING TO MANUFACTURER'S RECOMMENDATIONS
2. SAW CUT CONCRETE AS NOTED ON PLAN DETAIL THIS SEET
3. APPLY CHEMICAL STAIN AS DESCRIBED ON PLAN DETAIL THIS SHEET

**ADD ALTERNATE:**

1. SAW CUT, REMOVE AND DISPOSE OF EXISTING CONCRETE PER CIVIL ENGINEER'S TRAFFIC SAFETY PLAN AND SPECIFICATIONS
2. PLACE AND FINISH INTEGRAL COLORED CONCRETE AS DESCRIBED ON PLAN THIS SHEET AND PER TOWN OF ADDISON STANDARD CONSTRUCTION DETAILS
3. APPLY COLOR WAX CURING COMPOUND PER MANUFACTURER'S SPECIFICATIONS

NOTE: SAW CUT ALL JOINTS SHOWN TO DEMARCATÉ CROSSING, NO OVERLAPS ARE ACCEPTABLE. DO NOT CUT CURBS. SAW CUTS 1/4" TO 1/2" MAX. 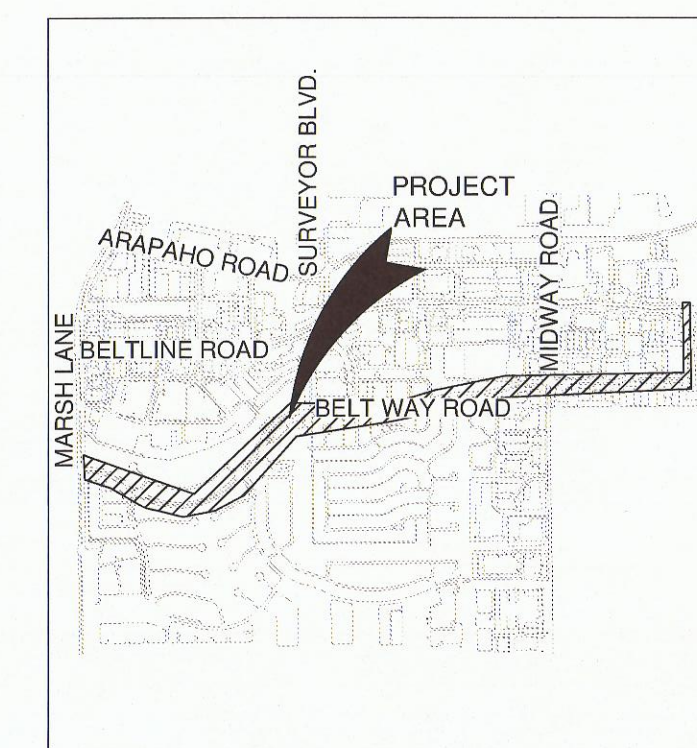

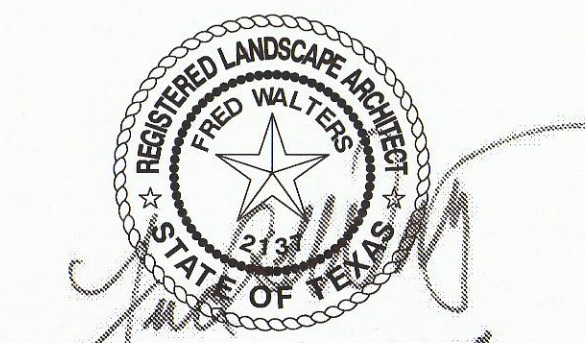

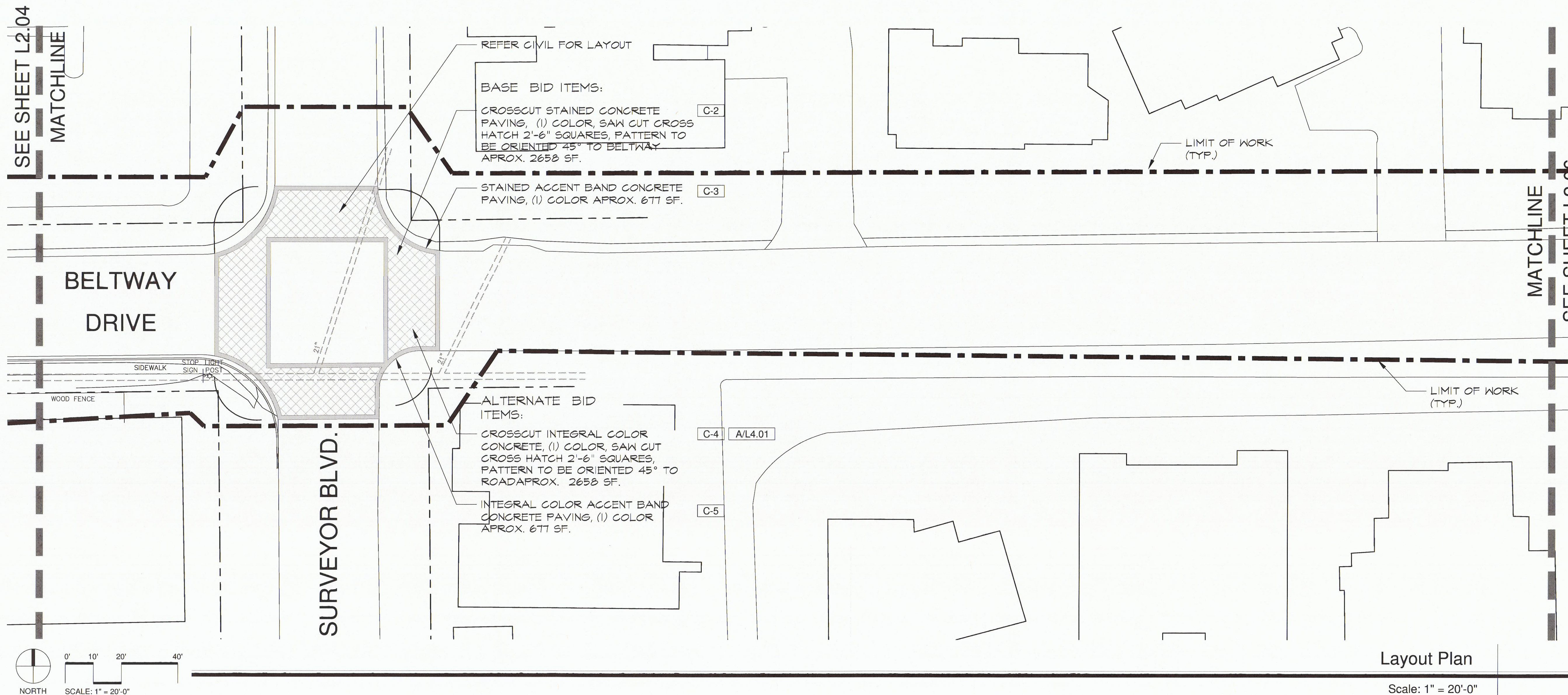
